Central Brooklyn is one of the most vulnerable areas in all of New York State, with measurably higher rates of obesity, diabetes, and high blood pressure; limited access to healthy foods or opportunities for physical activity; high rates of violence and crime; wide economic disparities due to unemployment and high poverty levels; and inadequate access to high quality health care and mental health services. Vital Brooklyn offers a holistic approach that focuses on eight integrated areas of improvement: open space and recreation; healthy food; education; economic empowerment; community-based violence prevention; community-based health care; affordable housing; and resiliency.
