**District Service Cabinet Notes:** 

- 1. 71<sup>st</sup> precinct is down in major categories except sexual assaults 2. Down 40% in robberies
- 3. Public Safety Team took 12 guns off street prior to Labor Day
- 4. 71<sup>st</sup> zero incidents for Labor Day. Shooting technically occurred in 77<sup>th</sup> precinct.
- 5. DCWP Home Improvement Wall of Shame A person or business must have a Home Improvement Contractor license to do work (home improvements or repairs) that costs more than \$200 to any residential building in NYC. The wall is a list of all home improvement businesses that received a violation for operating without a DCWP license within the last 12 months.
- 6. Requested for Dodger (Sullivan) and Winthrop (Rogers) Playgrounds to receive maintenance from Parks Dept.
- 7. 703 Midwood Street elevated to Manhattan DOB
- 8. HEAP The Home Energy Assistance Program (HEAP) can help eligible New Yorkers heat and cool their homes. Application opens November 1st
- CB9 will be holding a FY25 District Needs Statement/ Session on Thursday, September 26<sup>th</sup>, 2024, at 6PM here in the board office to hear community concerns AND ideas.
- NYC Department for the Aging (NYC Aging) Service Needs Assessment is a survey examining the needs of older adults living in New York City to assist with program planning and to allow for a better understanding of potential unmet needs. Completing the survey ensures that all of the city's diverse communities are represented. All responses to the survey are anonymous; however, NYC Aging will randomly select 50 households to receive a Visa gift card worth \$50. - City Planning Commission will be holding its VOTE for the City of Yes Housing Opportunity, which this board opposed, tomorrow morning, September 25<sup>th</sup>, 2024, at 11AM. The virtual participation details will be posted on NYC Engage prior to the hearing.
- Upcoming NYC Rules Hearings:

- Campaign Finance Board is proposing amendments to the Campaign Finance Board's (the "CFB") rules regarding: complaints, Conflict of Interest Board filings, contributions, disclosures, expenditures, independent expenditures, loans, public funds payments, registration and certification, statements of need, training, and transition and inauguration entities. The CFB will hold a public hearing on the proposed rules in person and online. The public hearing will take place at 1:00 p.m. on September 27, 2024, at 100 Church Street, 12th Floor, New York, New York 10007. You can email written comments to Rules@nyccfb.info.
- The New York City Human Resources Administration ("HRA") proposes to amend the Fair Fares program by increasing the income eligibility standard from 120 to 145 percent of the federal poverty level. The public hearing will take place remotely via Zoom on Monday, October 21, 2024, at 10:00 am. You can email comments to NYCRules@hra.nyc.gov. Please include "Fair Fares Amendments" in the subject line.
- The Taxi and Limousine Commission ("TLC") is proposing to amend its rules to require that all taxicab vehicles hacked up must be Accessible Vehicles in order to comply with a federal court order requiring that fifty percent of the City's taxicab fleet be attached to a Wheelchair Accessible Taxicab. TLC will hold a public hearing on the proposed rule. The public hearing will take place at 10:00 am on October 10, 2024. The public hearing will be held online using Zoom. There will be no in person public hearing. The public hearing will be livestreamed on TLC's website at www.nyc.gov/tlc. To participate in the public hearing, please e-mail the TLC at tlcrules@tlc.nyc.gov or call TLC at 212-676-1135 by 5:00pm on October 9, 2024. After you have signed up to speak, TLC will provide you with a Zoom URL to enter in on your computer or dial-in via phone number if you prefer to call in.
- The New York City Department of Transportation ("DOT") is proposing an amendment to Section 4-08 of the Traffic Rules to establish and implement a permit for the use of microhubs as part of a pilot program mandated by Local Law 166 of 2021 to aid in congestion reduction and increase freight sustainability. DOT will hold a public hearing on the proposed rule online. Members of the public may access and participate in this hearing online or by telephone. The public hearing will take place on Thursday, October 17, 2024 at 10:00am. You can email comments to rules@dot.nyc.gov.
- In Community District 9 the Brooklyn Roadway Resurfacing schedule is as follows: Wednesday, Thursday, and Friday – Lincoln Road between East NY Ave and Washington Ave; Friday only for Classon Ave between Eastern Parkway and President Street
- CB9 has not received additional information on the Prospect Heights skate park. We will work with CB8 if any public sessions are commenced.

- Yesterday, September 23<sup>rd</sup>, Gov. Hochul State Issued Declaration of Imminent Threat
  to Public Health for the Eastern Equine Encephalitis virus (EEEv) and urges New
  Yorkers to follow recommendations to reduce risk of mosquito-borne illness:
  measures include mosquito spraying, more insect repellent for visitors at state parks
  and campgrounds, and greater outreach to residents.
