VI. District Office Report – Dante B. Arnwine, District Manager

a. For the Empire Blvd. Reconstruction – A contractor discovered a sink hole at Empire Blvd./Washing Ave. Due to utility interference and the condition of the sink hole, the contract work was stopped to provide safety to allow DEP's contractor to stabilize the damaged underground utility. New direction was received for the contractor to conduct the sewer work and also to provide new submissions. Once the required documents are approved, the field work will resume. In the meantime, a Time Extension for 6/18/23 was submitted in order to complete the project. Update!! The week of December 12th the field office was informed that the new submission for the remaining construction work was approved, and the contractor anticipates resuming sewer work on Empire Blvd. between McKeever Place and Washington Avenue as soon as December 19, 2022.

- b. Construction at Flatbush & Lincoln Road They have suspended construction work at the location Flatbush Avenue and Lincoln Road due to the cold weather. They were working on road restoration and had to delay the construction because they cannot lay asphalt during the cold temperatures. They will begin construction on road restoration in March 2023.
- c. Bridge Street Development Corporation Crown Heights Consumer and Business Surveys will come out shortly for submission.
- d. Report derelict bicycles to 311. DSNY will remove derelict bicycles from reported locations.
