REVIEW BOARD

The NYC Department of Buildings is requesting applications from members of the construction, real estate, labor, technology, architectural, and engineering community, and other interested stakeholders, to participate on the Innovation Review Board that will meet on a regular basis.

Application/participation agreements will be accepted through **December 14, 2024**. If your application is accepted, you will be notified by the Department directly and invited to join the subject meeting based on your area of expertise.

BACKGROUND

Pursuant to Title 28 of the NYC Administrative Code, Section 103.1.3, the Innovation Review Board (IRB) will provide a formal opportunity for the Department and industry representatives to work together to review and evaluate cutting-edge technologies along with energy-reducing and sustainable technologies.

TIME COMMITMENT

The Innovation Review Board will meet on a regular monthly or bi-monthly basis. Participants are expected to be available to attend all scheduled board meetings. All work is on a volunteer basis. The Department cannot provide any compensation for work or travel.

BOARD MEMBER PARTICIPATION

Committee participants should be knowledgeable in the subject matter applicable to the theme or topic requested by the Innovation Review Board. Members may represent either a specific organization or be appointed to act on their own behalf due to their personal expertise in the subject matter.

Organizations whose interest is primarily in the areas of real estate, architecture, engineering, sustainability, labor, policy, or economics, and technology who wish to have representation on this Board, must provide a technical expert to represent their organization.

PURPOSE

The Innovation Review Board will convene to:

1. review specific projects that propose to employ new technologies, design or construction techniques, materials, or products, now including products referred from the Office of Technical Certification and Research, to be used at job sites, during plan examination, and for use by DOB Inspectors
2. review proposals for approval of and to initiate reviews of such technologies, design or construction techniques, materials or products in order to determine their economic, operational, environmental and sustainability benefits
3. make recommendations as to under what conditions and for what purposes each may safely employed in New York City, **and**
4. streamline approvals of specific innovative projects. This Board will seek to make reviews more efficient, streamline the approval of certain approvals, and foster inter-agency agreements.
