Abstract 2018 amended Consolidated Plan One-Year Action Plan

New York City's amended 2018 Consolidated Plan One-Year Action Plan was formulated using HUD's electronic Consolidated Planning system (eConPlanning) and consists of the following sections: Executive Summary, Citizen Participation; (One-Year) Action Plan; and, five (5) Appendices.

This version of New York City's Consolidated Plan is part of the City's activities to fulfill federal Consolidated Plan citizen participation regulations regarding availability of the Plan to the public which require localities to provide the public with reasonable access and opportunity to examine the document.

AMENDMENTS TO THE CONSOLIDATED PLAN

The amended 2018 Consolidated Plan constitutes a substantial amendment to the One-Year Action Plan (AP-) because it reflects the addition of certain Community Development Block Grant (CDBG)-funded programs. The amendment to New York City's CDBG-funded activities was triggered by the City's sale of a property that is within a Federal Urban Renewal Area. As a result, the CDBG program will receive a total of \$235 million from the proceeds of that sale. Of those funds, \$162 million will be allocated to programs within Calendar Year 2018 and \$73 million will be allocated to programs within Calendar Year 2019. The program income allocated within Calendar Year 2019 will be identified in the Proposed 2019 Consolidated Plan.

The \$162 million allocated in Calendar Year 2018 is targeted to the following programs:

DOE School Kitchen Renovations Program (new program in 2018 but actually a continuation of a program funded in prior years)
Environmental Inspections in City Shelters

Executive Summary and Formulation Process

The Executive Summary summarizes New York City's overall strategic objectives and outcomes as identified in the Proposed Plan's Needs Assessment section. The volume includes a summary of the Citizen Participation process used by the City to solicit input regarding the amendments to the Action Plan. In addition, an abbreviated Summary is also available in three (3) other-than-English languages (Spanish, Simple Chinese and Russian, respectively).

One-Year Action Plan

The One-Year Action Plan describes the City's amended use the formula entitlement funds for affordable housing, homelessness, supportive housing services and community development needs programs which were conceived either to directly or indirectly benefit low- and moderate-income households.

Appendices

In addition, there is a fifth volume which includes six (5) appendices: Description of Monitoring Activities for the four entitlement grants; Emergency Solutions Grant Written Standards; Definitions; Summary of Citizens' Comments; Certifications; and, Anti-displacement Plan.
