MXXXXX Chief Review Assessor (Finance) (1 position)  
MXXXXX Executive Deputy City Sheriff (Finance) (1 position)

We propose to classify the following non-managerial title, in the Non-Competitive Class, subject to Rule X, Part I:

XXXXX Investigator (Employee Discipline) (4 positions)  
95350 Secretary to the Deputy Commissioner (Finance) (4 positions  
increase from 2 to 4)

Part I positions are designated as confidential or policy influencing under Rule 3.2.3 (b) of the Personnel Rules and Regulations of the City of New York and therefore are not covered by Section 75 of the Civil Service Law.
