#### NOTICE OF PROPOSED ACTION PLAN AMENDMENT

TO RESIDENTS, BUSINESS OWNERS, GROUPS, COMMUNITY BOARDS AND AGENCIES:

New York City has completed a proposed amendment to its plan for the \$4.21 billion in Federal disaster aid from the Department of Housing and Urban Development (HUD) to help with recovery from Hurricane Sandy. The proposed Community Development Block Grant – Disaster Recovery (CDBG-DR) Action Plan Amendment 8 contains the following changes:

#### General

- Updates funding amounts for programs to reflect third allocation of CDBG-DR funds to New York City
- Revises key information contained within program descriptions and program start and ends dates to reflect updated information and timelines in all areas
- Updates need assessments and makes other non-substantial updates in all areas
- Identifies Planning and Administration funding for each program area, including Overall Grant Management

#### Housing

- Describes **\$639 million** in new housing recovery funds, enabling the City to serve all applicants to Build it Back, regardless of priority levels, and includes \$3 million for workforce development to train and connect Sandy-impacted residents to Sandy-related construction and other jobs
- Reallocates **\$200 million** to Build it Back from other prior allocations: \$96 million from Business programs, \$44 million from Infrastructure and Other City Services, and \$60 million from Resiliency
- Creates an optional Temporary Relocation Program to provide financial assistance for homeowners who must move during Program-provided construction
- Provides an option for homeowners to receive a direct grant to complete moderate repair projects (those projects not requiring elevation) instead of having the Program complete the construction work.
- Extends the Temporary Disaster Assistance Program (TDAP) rental assistance benefit to households from two years to four years

#### Resiliency

- Describes **\$355 million** in new funding for Rebuild by Design projects, including \$335 million for the Lower East Side and \$20 million for Hunts Point. The City is supplementing the Lower East Side project with \$3 million (see below) and Hunts Point with \$25 million from reallocated Business funds
- Provides **\$28 million** for Staten Island University Hospital resiliency programs
- Ends the Integrated Flood Protection System competition, freeing up **\$5 million** for direct design and planning, which will now cover \$3 million for Lower Manhattan flood protection, and \$2 million to study integrated flood protection systems in East Harlem and on the North Shore of Staten Island

#### Business

- Ends the Neighborhood Game Changers program and the Business Resiliency Investment Program (BRIP), freeing up **\$98 million** for other business-related and targeted resilience investments, including:
  - **\$3 million** for a business resiliency technical assistance program
  - **\$12 million** for implementation of a wetland bank at Saw Mill Creek in Staten Island
  - **\$15 million** for Coney Island storm water management and commercial corridor improvements
  - **\$15 million** for commercial corridor improvements in the Rockaways

#### Infrastructure and Other City Services

- Revises existing projects and identifies major infrastructure projects (defined as Covered Projects) and further details the City's response to impacts to public infrastructure

Notice of final rulemaking relating to amendments that pertain to the moratorium on street fair applications.

NOTICE IS HEREBY GIVEN PURSUANT TO THE AUTHORITY VESTED IN THE Office of Citywide Events Coordination and Management by Executive Order No. 105 of 2007, and in accordance with Section 1043 of the Charter, that the Office of Citywide Events Coordination and Management proposes to amend Chapter 1 of Title 50 of the Official Compilation of Rules of the City of New York relating to street activity permits. This rule proposal was not included in the regulatory agenda because it was not contemplated at the time of publication of the regulatory agenda.

Notice regarding a public hearing about the amendment was first published on November 7, 2014, with the agency accepting comments until December 8, 2014. The agency was prepared to make available for public inspection all written and oral comments it received on the matter, within a reasonable time after receipt, between the hours of 9:30 A.M. and 4:30 P.M. at the Office of Citywide Events Coordination and Management, 100 Gold Street, 2nd Floor, New York, NY 10038. A total of 3 comments were submitted - either at the public hearing or through other means (regular mail and the NYC Rules website).

This amendment will take effect immediately.

Statement of Basis and Purpose of Rule

The Office of Citywide Events Coordination and Management (OCECM), Street Activity Permit Office (SAPO) is charged with administration of the permit system for street activities, block parties and fairs.

Over two hundred SAPO-permitted street fairs and over 5,000 events occur annually within the City. Almost all of these events involve permits for the use of multiple blocks over several days, the erection of structures, the vending of food, apparel and other goods and the use of amplified sound and the performance of music. Such events require additional police presence and increase overtime expenditure by the City. In order to effectively deploy police resources, the New York City Police Department has requested for the calendar year 2015 that SAPO exercise its discretion temporarily to deny permits for additional events that place an excessive burden on police resources and divert uniformed personnel from core crime fighting, public safety and counter terrorism duties.

In the interests of protecting the City and its inhabitants, these rules will authorize SAPO to deny permits to events scheduled for calendar year 2015, the anticipated effective date of the proposed rules, if the event was not held in the calendar year 2014, the year prior to the effective date of the proposed rules.

SAPO authority for these rules is found in section 1043 of the New York City Charter and Executive Order No. 105 of 2007.

New material is underlined. [ Deleted material is in brackets.]

"Shall" and "must" denote mandatory requirements and may be used interchangeably in the rules of this department, unless otherwise specified or unless the context clearly indicates otherwise.

Section 1-05(d) of Chapter 1 of Title 50 of the Rules of the City of New York is amended to read as set forth below.

(d) For the calendar year [2014] 2015, the Director shall deny applications for street activity permits for street fairs not held in the calendar year [2013] 2014.

Statement of Substantial Need for Earlier Implementation

I hereby find, pursuant to Section 1043(f)(1)(c) of the New York City Charter, that there is a substantial need for the implementation, immediately upon its final publication in The



City Record, of a rule to clarify practices and procedures related to permitting events on City streets, including but not limited to extending, for an additional one-year period, the authority of the Director of the Office of Citywide Event Coordination and Management (OCECM), set forth in section 1-05(d) of chapter 1 of Title 50 of the Rules of the City of New York, to deny applications for street activity permits for events not held in the preceding calendar year and to promulgate a fee schedule for certain street activity permits.

Over 200 SAPO-permitted street fairs and over 5,000 events occur annually within the City. Almost all of these events involve permits for the use of multiple blocks over several days, the erection of structures, the vending of food, apparel and other goods and the use of amplified sound and the performance of music. Such events require additional police presence and increase overtime expenditure by the City. In order to effectively deploy police resources, the New York City Police Department has requested for the calendar year 2015 that SAPO exercise its discretion temporarily to deny permits for additional events that place an excessive burden on police resources and divert uniformed personnel from core crime fighting, public safety and counter terrorism duties.

In the interests of protecting the City and its inhabitants, these rules will authorize SAPO to deny permits to events for an additional year if the event was not held prior to the new effective date.
