# Enforcement of Fire Drills and Non-Fire Emergency (EAP) Drills to Resume May 1, 2023

On or about March 13, 2020, as concern mounted about the transmission of COVID-19 in New York City, the Fire Department issued a notice advising building owners that it would not enforce timeframes for Fire Code-required building fire drills and non-fire emergency (EAP) drills until further notice. Pursuant to the March 13, 2020 Notice, building owners were authorized, but not required, to postpone such drills.

COVID-19 restrictions have eased and the Bureau of Fire Prevention has observed that occupancies of all types are increasingly being re-occupied. Based upon these factors, the March 13, 2020 Notice is hereby rescinded. Effective May 1, 2023, the Fire Department will resume its enforcement of fire and non-fire emergency (EAP) drills required by New York City Fire Code Section FC401.7 and Fire Department Rule 3 RCNY \$401-07.
