City Council Expands Truck Side-Guards Law to Contractors

In 2015, DCAS partnered with U.S. DOT Volpe to prepare and publish a [report on the safety benefits of truck side-guards](#) as part of Mayor de Blasio's Vision Zero initiative. Truck side-guards are common sense safety enhancements that can prevent a pedestrian, bicyclist, motorcyclist, or child from getting caught by the back wheel of a truck and being badly injured or killed. In Europe and many places in the world, these guards have been standard and required for decades. In North America, these safety guards are still rare, something we are working to change.

After DCAS issued its report, DCAS launched what is now the nation's largest truck side-guard program, with over 3,760 side-guards in operation, and covering over 85% of the City fleet. All City agencies except DSNY have completed their installations. DSNY, which has the largest installation program amongst all City agencies, is at 76% completion. Led by Eric Richardson, Harris Kaplan, and Gary Prasad, the DCAS team helped create a marketplace and supplier base for the guards. When we launched this initiative, there was not a single supplier of truck side-guards in the United States. Today, DCAS is working with 10 companies: four different suppliers of guards and six qualified installers.



In June 2015, the City Council passed [Local Law 56](#), which requires truck side-guards on City fleet trucks and also trucks in the commercial waste industry in NYC as overseen by the Business Integrity Commission (BIC). DCAS has worked with BIC and also NYC DOT to implement this law. NYC's partnership with the Volpe Center on truck side-guards received a national [Federal Laboratory Consortium Award](#) in 2016.



In October 2021, the City Council, led by Transportation Chair Ydanis Rodriguez, passed [an additional law](#) that expedites the completion date for City trucks and commercial waste trucks. As importantly, this law expands the truck side-guard requirement to vendors who use trucks as part of City contracts through City government. DCAS estimates that up to 1,000 contracts and 5,600 trucks may be impacted by the

new law. The law will impact new contracts of \$2 million or more that are put in place as of January 1, 2023. DCAS will work with all City agencies with truck-related contracts to educate vendors on these provisions and enforce and inspect the implementation.

In 2022, DCAS will also conduct a vendor education effort regarding the new law and the safety importance of truck side-guards, as well as establish rules for the program.

Thanks to the City Council, Mayor's Office of Legislative Affairs, DOT, Law Department, OMB, and DCAS for their work on the new law.
