### Fleet Spotlight: DCAS Commissioner Lisette Camilo

This week, we spotlight our own DCAS Commissioner, Lisette Camilo, who was [appointed to lead DCAS by Mayor de Blasio in January 2016](#).

Under Lisette's leadership, the citywide fleet program has thrived. She has been engaged every step of the way as we have launched the nation's leading public electric fleet and charging program, successfully added NYCHA Fleet to our consolidation efforts, expanded our biofuel initiatives, introduced the Fleet Office of Real-Time Tracking (FORT), and implemented the Safe Fleet Transition Plan as part of Vision Zero.



Prior to COVID-19, Lisette had helped to advocate for additional fleet acquisition funding for citywide fleet and increased mechanical staffing. Lisette also helped us to navigate many inter-agency challenges stemming from the fleet and commuting reduction requirements of Executive Order 41, which is now fully and successfully implemented. By the numbers, we have made progress in nearly every area of fleet performance.

When COVID-19 introduced an extraordinary and continuing challenge for all of us, Lisette led DCAS through the crisis as DCAS took on COVID-related procurement, personnel, and facility roles beyond what our agency had faced in recent memory. Under Lisette's guidance, DCAS procured much-needed emergency supplies at an incredible scale and critical speed, implemented remote work across City government, and developed procedures to safeguard our facilities for those who continued to report to work in person. Lisette's calm, laser focused, and responsive approach has served DCAS and NYC well during its longest crisis.

Yet, today, under Lisette's leadership, the combined environmental efforts of our Energy, Fleet, and Facilities divisions are setting an example for cleaner power, vehicles, and buildings that has become a national model for environmental leadership.

She has expanded access to civil service tests for all New Yorkers and navigated the complex intricacies of Human Capital management during the many phases of the COVID-19 response, including the return to office. NYC Fleet and DCAS Deputy Commissioner Keith Kerman were recently recognized in the 2021 Climate Leadership Awards.


