DCAS Expands Solar Carport Network

DCAS Commissioner Dawn Pinnock announced on February 10, 2023 that [DCAS will be adding 71 freestanding solar carports to our existing network](#) of 85 solar carports. DCAS's solar network is the largest of its type in the country.

The solar carports are completely free from the electric grid. All power is generated from the sun and is stored in electric batteries connected to each unit. The carports are mobile and can be readily moved by forklift and flatbed truck for more optimal placement or in emergencies. As the position of the sun changes throughout the day, the solar arrays tilt and adjust to best capture available sunlight.

These units will be assigned to City agencies to support electric vehicle charging. Agencies operating and receiving carports include NYC Emergency Management, NYC Parks, the Department of Sanitation, the New York City Police Department, the Department of Correction, the Department of Transportation, DCAS, the Department of Design and Construction, the Department of Education, the Department of Health, the Department of Environmental Protection, and NYC Housing Authority. DCAS expects to get at least 20 years of use from each carport. [Our first solar carport debuted in September 2015.](#)

The new carports have a storm resilient design with the electric battery elevated above the ground. The battery was on the ground level for our first generation of carports and we did experience flood damage on a number of units during Hurricane Ida. This new design will greatly eliminate that risk.

The primary purpose of these carports is to support agency fleet charging and emergencies. However, DCAS does currently offer three carports for [general public access](#), and we will be looking to expand public access as the rollout continues this spring and summer.

These units will join over 1,400 other chargers in the DCAS network, one of the largest in the country. DCAS plans to add at least 500 chargers in the next year, including fast chargers, the solar carports, level 2 (slow) chargers, and other resilient charging models.

Thanks to DCAS Fleet Chief of Staff Sherry Lee, Deputy Agency Chief Contracting Officer Masha Rudina, and Assistant Fleet Commissioner Brent Taylor for their work on this initiative.
