Celebrating the 2023 High School Automotive Summer Interns

On August 8, 2023, DCAS Commissioner Dawn M. Pinnock and NYC Chief Fleet Officer Keith Kerman joined Adam Breier, deputy executive director of career and technical education (CTE) at NYC Public Schools, along with fleet agencies including NYPD, DSNY, FDNY, Parks and DOT, to celebrate and recognize this year's class of high school automotive interns. The recognition event was held at NYPD's Shop 4 in Queens.


This year's class was made up of 44 students, our largest program post COVID. Since 2015, DCAS and fleet agencies have hosted 405 automotive high school interns in paid

summer jobs. These internships are coordinated by the Department of Education Career and Technical Education (CTE) program and are funded through federal grants.

Automotive internships started on July 10 and end on August 18. Students learned hands repair and maintenance skills on all types of vehicles including all-electric enforcement units. They assisted in installing vehicle safety retrofits such as telematics, surround cameras and pedestrian alerts. A group of 12 students also took our in-person defensive driving class. Along with these students, DCAS interns also learned fleet operations such as processing crash claims.

DCAS is completing a donation of 15 electric vehicles to six schools to enable automotive high students to learn to repair and service these type of vehicles in the future. NY1 [featured](#) the donation to McKee High School in Staten Island in May.

With DCAS being a national leader in biofuels development, some interns are also working on obtaining biodiesel certifications through a program offered by DCAS and the American Lung Association.

Graduating from an automotive high school provides a direct pathway to city employment as an auto service worker. The certifications and graduation from a NYC automotive high school satisfies the two-year experience requirement for the auto service worker exam and offers a direct pathway to join city government. At the event, DCAS encouraged the students to look to join NYC government in one of the 1,800 full time fleet professional positions, or in other agency roles. Many students expressed strong interest to become City mechanics.




