
ACQUISITION FOR ROADWAY IMPROVEMENTS IN ARTHUR KILL ROAD, S.I. DDC CAPITAL PROJECT ID: HWR1140A

The City of New York through its Department of Design and Construction (DDC), proposed to acquire the highlighted street areas below for the reconstruction of roadways, sidewalks and curbs, pedestrian ramps, sewers, and water mains within Arthur Kill Road, Staten Island.

The properties to be acquired are shown below on what is the title sheet of the proposed Damage and Acquisition Map No. 4267. No homes are being acquired in this project. Rather, this proposed acquisition is for lotted and unlotted properties, all within the mapped street.

At the public hearing, DDC will outline the purpose, proposed location and other information about the project. There will be an opportunity to provide comments on the record and for a limited period after the public hearing.

Upon the conclusion of the public hearing, DDC will be available to answer questions as to how the properties to be acquired are impacted.






3. Please fill in your contact information. You may submit comments prior to the public hearing on this form, at the public hearing, and/or for a limited period after the public hearing.
