RESOLVED That the Design Commission, having considered designs for the construction of two segments of a greenway as part of the Randall's Island master plan, beneath the Amtrak viaduct from the Bronx Kill to the Hell Gate rapids, Randall's Island, Manhattan, submitted by the Economic Development Corporation and the Department of Parks & Recreation, represented by exhibits 5914-BZ, CA & CB of record in this matter, hereby gives to the same unanimous preliminary approval subject to the submission of any/all signage for committee review prior to developing final drawings. The Commission commends the design.

The Commission is concerned, particularly given the impact on the current project, and more broadly, the overall aesthetic of Randall's Island, that the Candela pole in a silver finish was not installed, as approved (on July 24, 2006 as part of the construction of 65 athletic fields and four comfort stations), and this change to a black finish was not submitted for review by the Commission prior to installation, per standard procedure. The Commission requests written clarification of (1) whether this change was the result of the Department of Transportation's policy at the time as well confirmation of its current policy with regard to the installation and maintenance of Candela poles; and (2) why the bronze plaque with the logos of the agencies and organizations involved in the waterfront pathway project (approved July 14, 1997; approval extended April 10, 2000) was not submitted for review and approval either as part of the original design or as a modification to the approved design, per standard procedure.


