Approval is given with the understanding that the team will (1) update the tablet interface to (a) indicate free Wi-Fi and 5G service capabilities and (b) allow the public to provide feedback on the design of the poles and service; (2) provide details on the community reception of the poles, including the design and provisioning of service; (3) include a decal with a symbol on the pole to indicate the 5G and/or Wi-Fi service and ensure that the sticker is re-applied if removed; (4) submit local and global examples of multi-tenant 5G pole structures sited on sidewalks in comparable dense urban neighborhoods with the goal of suggesting alternatives for a pole design in Residence Zoning and Historic Districts; and (5) remove and replace the pilot installations in the event another design is selected for citywide installation in Residence Zoning and Historic Districts. The Commission notes that the overall program will provide free Wi-Fi and 5G mobile carrier service to neighborhoods that are underserved, and any additional poles above this Phase I pilot for 200 poles must be submitted for review, per standard procedure.

Final approval is conditioned upon commencement of work before September 12, 2024 and submission of comprehensive photographic documentation of the completed project consisting of 8" x 10" archival-quality color photographs.
