

**Local Law 37 of 2005 as amended by Local Law 56 of 2021  
Changes to Pesticides Listed as Carcinogens or Developmental Toxicants since May 24, 2021**

The New York City Health Department (Department) submits this report pursuant to Local Law 37 of 2005, as amended by Local Law 56 of 2021, which, among other mandates, requires the Department to report annually on changes since May 24, 2021, previously April 1, 2005, to certain lists of pesticides; and on agency use of pesticides subject to these changes.

1. U.S. Environmental Protection Agency (EPA) List of Carcinogenic Pesticides

**Table 1** contains chemicals that were added by the EPA Office of Pesticide Programs to the list of chemicals having carcinogenic potential since May 24, 2021, and the quantities of pesticide products containing each of those chemicals used by city agencies in 2021.
