



Local Law 79 Runaway and Homeless Youth (RHY) Services Access Report January 1, 2024 to June 30, 2024 Summary to the NYC Council

DYCD funds Runaway and Homeless Youth Services, including residential programs for youth ages 16-24. DYCD-funded Drop in Center, Crisis Services and TIL Support Program providers are required to report each young person who is unable to access an RHY bed on the date they sought services.

RHY providers report daily bed availability over the six-month report period. During the period of January 1 to June 30, 2024:

- 1,122 young people were placed in a crisis services or transitional independent living support program.
- RHY providers submitted 1,127 Residential Access reports for youth not able to access a bed on the day they sought placementⁱ.
- Approximately 16% of reported youth attempted to access a DYCD-funded bed on more than one occasion.
- DYCD funds RHY beds for gender-identified males, females and other, as well as beds for young mothers and their children. Over the report period, approximately 95% of reports were submitted for youth seeking a male bed for which there was no available match on that day.ⁱⁱ
- 789 Residential Access Reports were for RHY (16-20) beds, the remaining 338 were for older youth under age 25.ⁱⁱⁱ

DYCD will continue to monitor service referrals to ensure that placement protocols are followed.

ⁱ Any youth who is unable to access a DYCD-funded RHY bed on the day that they are seeking service will be referred to available resources in the adult shelter system or to asylum-seeker services.

ⁱⁱ DYCD funds a total of 813 residential beds. Of that total, 60 beds are allocated for young adults (HYA) ages 21 – 24 and 82 are allocated mother-child beds.

ⁱⁱⁱ Fourteen minors presented themselves as in need of a bed on a day when no bed was available and were connected to resources through Children’s Services.
