Upon reading and filing the petition of Peter L. Zimroth, Corporation Counsel of the City of New York, verified the 16th day of February, 1988 petitioning this Court for an order pursuant to Sections 478 and 484 of the Judiciary Law for approval of a program of activities for law students and certain law school graduates awaiting admittance to the Bar, acting under the supervision of the Corporation Counsel in proceedings in the State Courts of Records, and due deliberation having been had thereon, it is

ORDERED, that the order dated March 26, 1984 (Appendix A) as granted by the Appellate Division of the Supreme Court of the State of New York, First Department, is continued as amended in Paragraph 2 and reads as follows:

1. That the following program of training, supervision and activities for law students and law school graduates awaiting admittance to the Bar, working under the supervision of the Corporation Counsel in proceedings in the State Courts of Record is hereby approved pursuant to Sections 478 and 484 of the Judiciary Law, and subject to the conditions and limitations set forth herein.

2. A law student who has completed at least two semesters of his law school course of study at an approved law school will be eligible for selection for the program by the Corporation Counsel. During the academic year students will be recruited for the program from the law schools in New York City as well as from other approved law schools.

3. Graduates from a law school who have taken the examination for admission to the bar immediately available after graduation from law school or the examination immediately available after being notified by the board of law examiners that they failed to pass said examination, and who have not been notified by the board of law examiners they have failed to pass two such examinations, all of whom are acting under the supervision of the Corporation Counsel, will be eligible for selection for the program of the Corporation Counsel.

4. Senior law students and graduates from law schools participating in the program will perform the duties, functions, and responsibilities of assistant Corporation Counsels in the following activities:

a. Preparation and argument of motions, including proceedings brought pursuant to Article 78 of the CPLR, in all courts except appellate courts;

b. Presentation of petitions in persons in need of supervision, juvenile delinquency, paternity, Uniform Support of Defendants Law, support, custody and child protective

proceeding in the Family Court and, with the approval of the Court in other proceedings;

c. Appear for the City in actions in landlord and tenant cases for the collections of rents and eviction of tenants and, with the approval of the Court, other matters in the Housing Part of Civil Court;

d. Appear for the City of New York in affirmative actions for the collection of money for hospital bills, property damages and delinquent taxes;

e. Appear for the City in proceedings before administrative agencies and, with the approval of the Court, judicial reviews arising therefrom;

f. Defense of all actions in the Small Claims Court up to the jurisdictional limit;

g. Appear for the City in all actions in Civil Court;

h. Prosecution in the Criminal Court of violations of the Administrative Code of the City of New York, or of any local law of the City of New York, of the New York City Health Code, or the rules and regulations of any department, bureau, board or commission of the City, or of any statute of the State of New York, when the action is prosecuted by the

Corporation Counsel of the City of New York on behalf of any agency of the City of New York;

i. Appear for the City of New York in examinations before trial;

j. Perform all duties, functions and responsibilities of attorneys in the conduct of the foregoing activities, including interview with clients and witnesses, investigations, legal research, drafting documents, briefs and memoranda of law and appearances before courts and administrative agencies, provided that the services are incidental to the foregoing authority and that the final drafts of any document prepared by a third-year law student or a law graduate awaiting admission is approved by an attorney.

5. All students and law school work will be carried on under the supervision of one or more Assistant Corporation Counsels. The Corporation Counsel will undertake to insure that each student and law school graduate selected for the program has had instruction on professional responsibilities, obligations and ethics of an attorney licensed to practice in New York.

6. In those cases where the students are to receive course credit for their participation in the program, the Corporation Counsel will certify their proper performance; and it is


FURTHER ORDERED, that the foregoing program is approved
