See ESCR CAG Page for presentation and recording from last April CAG meeting where Julie Freeman from the NYC Office of Management & Budget provided an overview of the Section 106 process as it related to the Fireboat House.

- 10. PA1 Air Quality Monitoring (see slide 29)
  - a. There have been a few exceedances; many of them were around the 15–25-minute mark. A few were a bit longer. Now we're entering the summer, and the contractor will use the watering truck more. They've also been applying dust suppression techniques and will do so more frequently in the summer.
- 11. Local Law 72 notification transparency regarding hazardous lead levels in soil (*see slide* 30)

- a. Soil testing earlier this month (as part of usual compliance procedures) detected a lead concentration of 5.56 mg/L which exceeds the USEPA limit of 5.00 mg/L. The soil is not homogenous given that it's urban fill material, so differences can be expected. Moving forward, any soil excavated from that area will go through air monitoring that is in addition to the pre-existing air monitoring locations.

    - i. It may seem that roads are closed when no work is happening, but it's in anticipation of ConEd work that may only be for a portion of the day, and we need to provide them with that access. We appreciate your understanding.

#### Q & A

Dov: Near Pier 42, we noticed that some of the new plants were already dying. A construction worker told me there was no irrigation system set up there. I don't know if that's correct, but I wanted to bring it to everyone's attention.

Desiree: Pier 42 is not part of ESCR. Paula and I talked about this the other day, and she reached out to the CCL for the Pier 42 project (Rick Fogarty) about it.

Paula: Yes, but I haven't heard back yet.

Robin: What time at night will the bridge process start, and when will it be open for us to use? Desiree: It starts at 12:01 am on June 8<sup>th</sup>. We anticipate it will open in September when we open ball fields 1 and 2.

Robin: I guess the bus is being re-routed. Will that whole access road be closed at Houston so that no cars can go down it?

Desiree: There will be a partial closure on the south service road. We've had this detour in the past, so folks go up Delancey Street down to Lewis Street.

Dianne: The work that's going on in ball fields 3, 4, and 5. Between the esplanade and the ball field where the strip of grass and trees used to be there's a big excavation that looks like a moat, and it keeps filling up with water and draining and filling up with water and draining. Is this a normal part of the construction, and what is going on in that space?

Desiree: They're building the tide gate chambers down in there; we want come back with a little more information about this at the next CAG meeting. Earlier on in the process during the beginning stages of utility work south of the Williamsburg Bridge we spoke about the dewatering process. I will go back to our team and try to find out some more information about that, but we do have that dewatering process down there as well.

Dianne: OK, great, because it looks like it's sloshing in and out with the tide. The water's not still; it moves.

Wendy: We made a list of questions about the north end of PA1, and I thought we'd get some answers about them tonight.

Paula: We sent that list to Parks, and we heard from them today that they're working on them but won't have any answers ready for tonight.

Wendy: The few trees that are left are doing so much good work in that area around 6<sup>th</sup> Street and 10<sup>th</sup> Street. Is there any timing around or possibilities of looking for looking at more of a gate situation there rather than mowing everything down?

Desiree: As we've mentioned, the trees need to be removed due to the grade changes in the park. We don't have exact timing on when we're going to move forward. As

promised, we're not closing any further portions of the park until we open the lower portion.

# **CAG-only portion**

Michael: I was hoping Frank was going to be on the call today... At Corlears we're having issues with is construction workers parking illegally all along the park every day. I send pictures to Desiree every day, we started going 311 requests, and people are starting to get tickets now, but they're parking right on the tree beds. I don't know what else we can do about it. I wonder if Frank and Gouverneur Gardens are having the same issue. When I used to send the photos to Parker, he would share them with the construction manager. It's not really something for the CAG to get involved with; it's just an annoyance for me.

Ayo: Why don't you call your precinct to see if they can issue some warnings?

Michael: They've come and ticketed a few times, but I do have an email out to Detective Soto.

Ayo: My next suggestion is that you paper their cars with notices from the community.

Wendy: The new DEP person for resiliency was at this month's CB 3 meeting; they're the agency in charge of all the movable gates around the city. I think it would be good for them to come to the CAG sometime, especially with all the operations-related questions about how that would work. Also, regarding one of the commitments, we still haven't had any preparedness training in the community, and there are new systems in place in some of the most vulnerable buildings that people don't know about. There's something that could be useful coming out of a meeting with DEP and their new resiliency department.

Wendy: On Avenue C at 10th Street there's a major repair of the steam system going on; does it have anything to do with the work going on in the park? They're putting a mini-tunnel of some sort underneath the 10<sup>th</sup> Street bridge. I know there's a lot of construction equipment in that area.

Katie Loeb: To my knowledge they're not connected, but I can find out. The parallel conveyance work is between Avenue D and the FDR, and the steam work is around Avenues C and D. We can find out if they're impacted by each other, but I believe they're two different projects.

Wendy: I hear there are all kinds of issues in that area with steam coming out of the ground. Richard: It's been that way for years. We've had steam leaks on Avenue C up as high as between 11<sup>th</sup> and 12<sup>th</sup> Streets. The corner of 10<sup>th</sup> and C has had repeated cave-ins. They did a major project a year or two ago that seems to have held for a while, so it's kind of disconcerting that they're there again.
