### Social Media Toolkit

#### Dear Partners,

Fair Fares NYC is a city program created to help New Yorkers with low incomes manage their transportation costs. Eligible New York City residents receive a 50% discount on subway and eligible bus fares. Pay-per-Ride, weekly unlimited, and monthly unlimited options are all available. Fair Fares can also provide 50% off MTA Access-A- Ride paratransit trips.

Fair Fares is open to eligible low-income New Yorkers who don't have discounted transportation from the MTA or the city.

Fair Fares has expanded access by increasing the income threshold to qualify for the program.

Now eligible New York City residents ages 18 to 64 with incomes up to 145% of federal poverty levels may enroll.

Starting mid-February 2025, all Fair Fares NYC participants will be transitioned from Fair Fares NYC MetroCard to using the FFNYC discount with OMNY. FFNYC will no longer issue Fair Fares MetroCards. FFNYC will begin issuing Fair Fares NYC OMNY cards to use with the discount at enrollment, renewal, or replacement. Current participants can use their FFNYC MetroCards until one of the following occurs: the card expires, no longer works, gets deactivated, or is no longer enrolled in the Fair Fares program. Participants may switch from MetroCard to OMNY at any time via ACCESS HRA.

We need your help promoting Fair Fares in the months ahead. Let's make sure we can notify as many New Yorkers as possible about this program to help low-income New Yorkers move ahead.
