# How to obtain proof of receipt of Public Assistance (PA) or Supplemental Nutrition Assistance Program (SNAP) Benefits

If you are receiving PA (also known as Temporary Assistance (TA) or Cash Assistance (CA)), or SNAP benefits, and are asked to provide proof of receipt, there are multiple ways to obtain this type of proof.

You may:

- Use the approval notice that was sent to you in the mail;
- Ask your caseworker at your local social services office for a copy of your PA (also known as TA or CA) or SNAP approval notice or budget; or,
- Use ACCESS HRA if you reside in (NYC) or myBenefits if you reside outside of NYC.

For more information on how to obtain documentation showing that you are in receipt of PA/TA/ CA or SNAP benefits through ACCESS HRA or myBenefits, please use the following guide.

#### Accessing documents through myBenefits

myBenefits can be accessed by visiting: <u>https://mybenefits.ny.gov</u>. If you do not already have an account, you may create one.
