## St. Anthony of Padua Church





- Falls within Sullivan Thompson Historical District which was designated in December 2016.
- Tax address is 151-155 Sullivan Street, New York, NY, 10012
- Lies on corner of West Houston St. and Sullivan St. in SoHo.
- Due to the large Italian immigration in the 1850's the church was built to provide the Italians with an Italian speaking parish.
   It is close to the Little Italy neighborhood.



## **History of Building**



Architect's Render from 1886

- Church built from 1886 1888
- Designed by Arthur Crooks for Reverend Father Anacletus De Angelis
- Dedicated June 10, 1888 First Italian Parish in NY State
- Oldest Existing Italian Parish in USA





## **History of Building**



West Houston Street being widened to 6 lanes in early 1930's to accommodate new subway line. Multiple buildings on either side of the street were demolished for the street.

St. Anthony of Padua Church in 1966




Interior of the Church

- Appeared in movies such as "The Pope of Greenwich Village," "Moonstruck," and "Godfather II."
- It is currently the oldest Italian parish in the USA and serves as a frequent tourist attraction to the Soho area



#### **History of Courtyard**




- Statue of Our Lady of Fatima and supplemental statues (Center) installed by Father Felician Napoli in 1976
- Statue of St. Alphonsus (Left) installed by Reverend Patrick Boyle in 1997
- Statue of Padre Pio (Right) installation date is unknown sometime after 1992
- Per Church Records, when Father Felican Napoli installed the Fatima Group in 1976, the asphalt pavement had already been installed.





#### **History of Our Lady of Fatima Statue**




- Originally located at St.
   Anthony Church Seminary
   Grounds at Troy, New York
   with other statues including
   the Sacred Heart, St. Anthony,
   and St. Francis.
- When Seminary Grounds closed in 1976, Father Felician Napoli moved the statues to the church and installed Fatima Group as well as statues of Sacred Heart, St. Anthony, and St. Francis in the courtyard of the church.
- Fr. Paul Rotondi became pastor in 1979 – in early 1980's he removed statues of the Sacred Heart, St. Anthony, and St. Francis and relocated them to Wappingers Falls.





#### **History of St. Alphonsus Statue**




- Originally located at St. Alphonsus Church, which closed in the early 1980's and was amalgamated into Parish of St. Anthony.
- Parishioners from St. Alphonsus Church requested that Statue of St. Alphonsus be located in the courtyard of St. Anthony Church – Fr. Paul Rotondi did not allow the statue to be installed in the courtyard. Parishioner John Pepe took the statue and held it in his garage on Canal Street.
- Reverend Patrick Boyle became pastor in 1996, and in August of 1997 he was responsible of moving the statue of St. Alphonsus from John Pepe's garage to the courtyard of the Church of St. Anthony.





#### **History of Padre Pio Statue**



- Per Reverend Patrick Boyle, he left the Church of St. Anthony of Padua in 1992. At that time, the only statues in the courtyard were the Fatima Group and St. Alphonsus.
- The installation date of the Statue of Padre Pio is unknown. It was installed sometime after 1992 when Reverend Patrick Boyle's service ended.



#### **Current Status**




Historic Sign

- The original installation date of the sign is unknown.
- The historic sign was removed under previous ownership in 2021
- As it is now, the Church cannot be easily identified by a passersby.



**Existing Courtyard Plan** 



- The existing asphalt is damaged resulting in water pooling.
- The extensive cracks provide a potential tripping hazard.
- As is, the existing courtyard is unattractive.



Proposed Courtyard Plan


- We proposing building a new statue base with a new grotto.
- We are proposing installing new courtyard paving, curbs, and walkways.
- We are proposing to legalize the existing HVAC units

- We are proposing the installation of a new planter and vegetation screen around the existing HVAC units.
- We are proposing the installation of a new sign and corresponding lighting system at the existing elevator bulkhead





#### Walkway Replacement/New Curb

- We are proposing to replace the existing walkways and curbs in kind to provide a safe and smooth walking surface.
- This will restore adequate drainage.
- This will ensure ADA code compliant.

#### **Proposed Statue Base**



- The new base veneer stones will match those on the existing base.
- We are proposing that the new base be taller than the existing to discourage vandalism.
- We are proposing that the new base be places further away from the street as an additional safeguard against vandalism.
- We are proposing the addition of a grotto behind the statue made from the same veneer stones to match the existing base.













Proposed Statue Base West Elevation




Sign Letter Dimensions

Proposed New Sign and Statue Location


- We are proposing to remove existing lighting and provide new lighting fixture at existing junction box.



- We are proposing a planter and vegetation screen to minimize visual impact






