














PROPOSED CELLAR / VAULT PLAN




## **First Floor Plan**






#### PROPOSED FIRST FLOOR PLAN




## Second Floor Plan





APPROVED NEW SECOND FLOOR PLAN




#### PROPOSED NEW SECOND FLOOR PLAN










## **Roof Plan**
