






VIEW D: LOOKING AT SOUTHWEST CORNER




PROPOSED: FULL HEIGHT SECTION DETAIL OF TYP. SIMULTED DOUBLE-HUNG WINDOW

EXISTING: SECTION DETAIL OF TYPICAL ALUMINUM REPLACEMENT DOUBLE HUNG WINDOW


PROPOSED: SECTION DETAIL OF TYPICAL SIMULTED DOUBLE HUNG WINDOW




