16. I will conspicuously post this stipulation form beside my liquor license inside of my business.

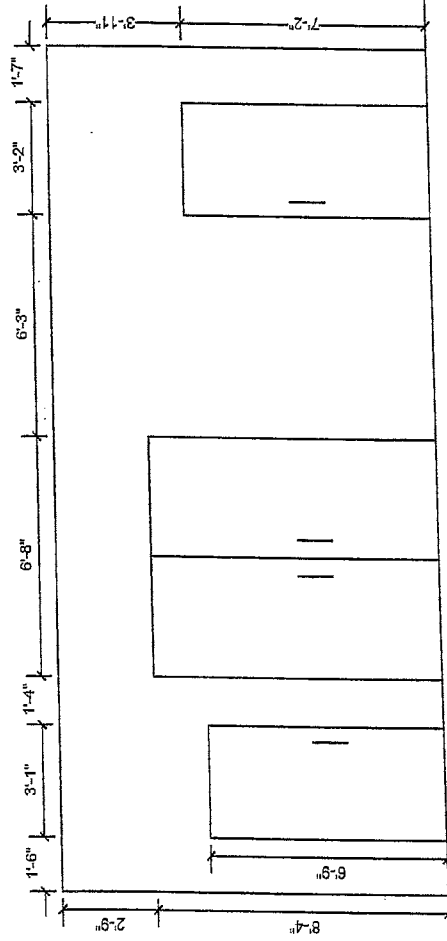

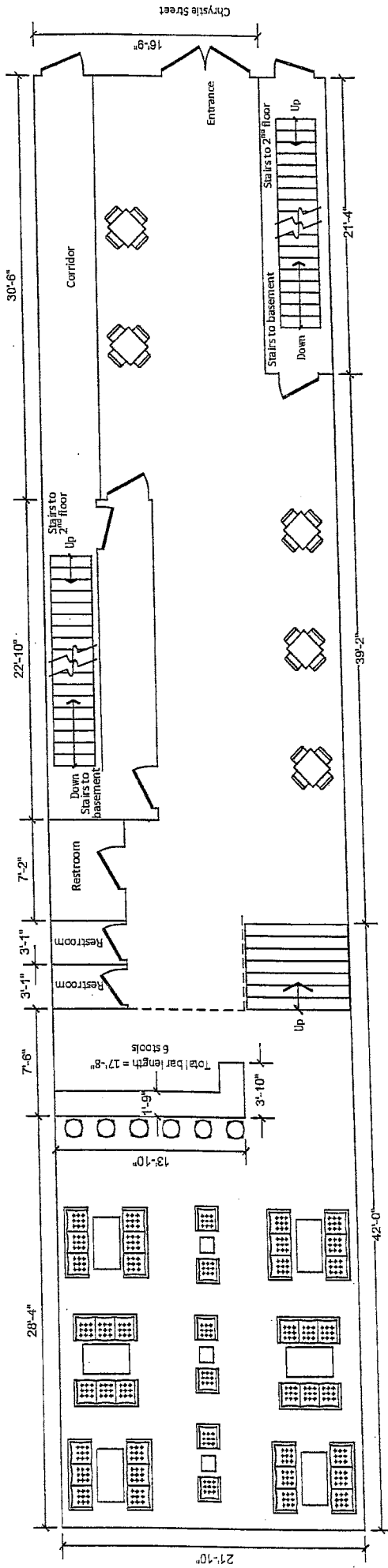

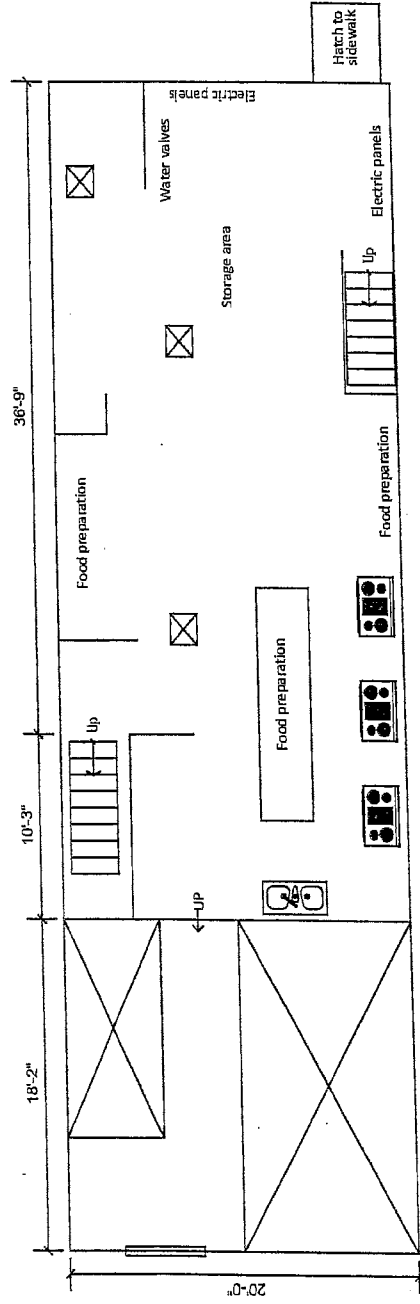
