


Floor Plans

Good morning:

We wanted to contact your organization to let you know that Celebrate Everything LLC dba Champagne Wishes will be opening a themed restaurant at 112 Stanton Street between Ludlow and Essex Street. They will be applying for a beer and wine license. The former business at the premises was Sushumai Asian Fusion Inc dba Sushumai Asian Fusion that operated with a beer and wine license from 2017 to September 2023.

The new restaurant will request that guests make reservations by prepurchasing tickets and each ticket will include a full meal including dessert. The meals will focus on celebrations such as promotions, anniversaries, engagements, birthdays, etc. Customers will have a meal centered around a celebration of their choosing. One of the meals will be named a "fancy girl dinner" which is a high-end meat and cheese plate stacked on a large tea tray. Other offerings include full meals such as pasts, fish and meat dishes.

The ground floor will have approximately 68 seats with a 15' customer bar with 9 bar stools and the cellar will have approximately 24 seats. There will only be background music played at a low volume level and there will not be any outdoor spaces. The proposed hours of operation are 8am to 12am Monday to Sunday.

The owners Morgan First and Tyler Balliet owned and operated Rose Mansion. The first location was located at 445 Fifth Avenue and operated with a summer seasonal beer and wine license from July 2018 to November 2018. Rose Mansion then moved to 100 West 33rd Street and operated with a beer and wine license from May 2019 to August 2020. The venue closed due to the pandemic.
