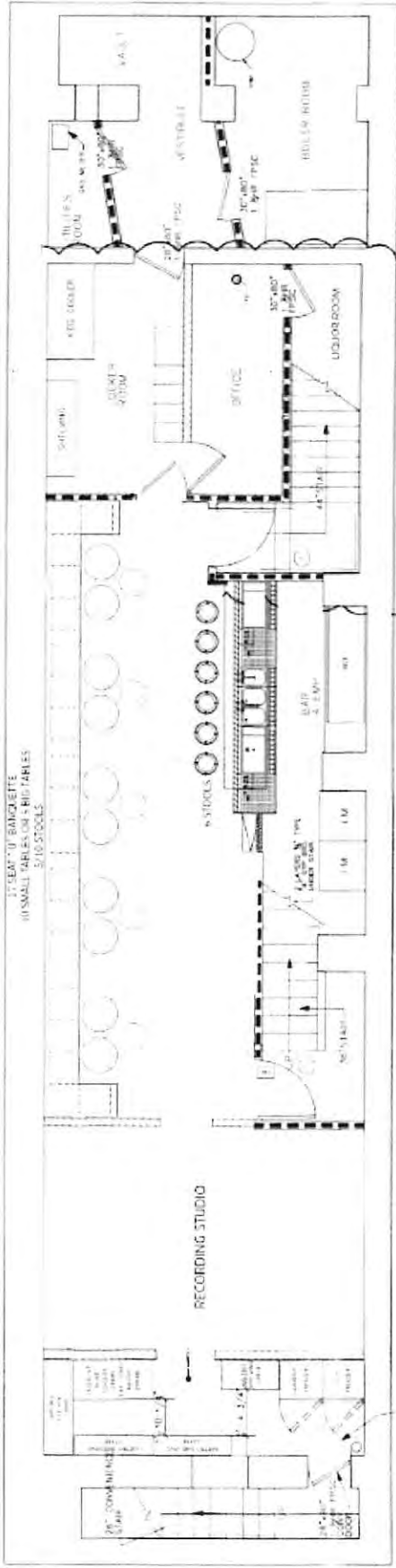
GROUND FLOOR



Mezzanine Level

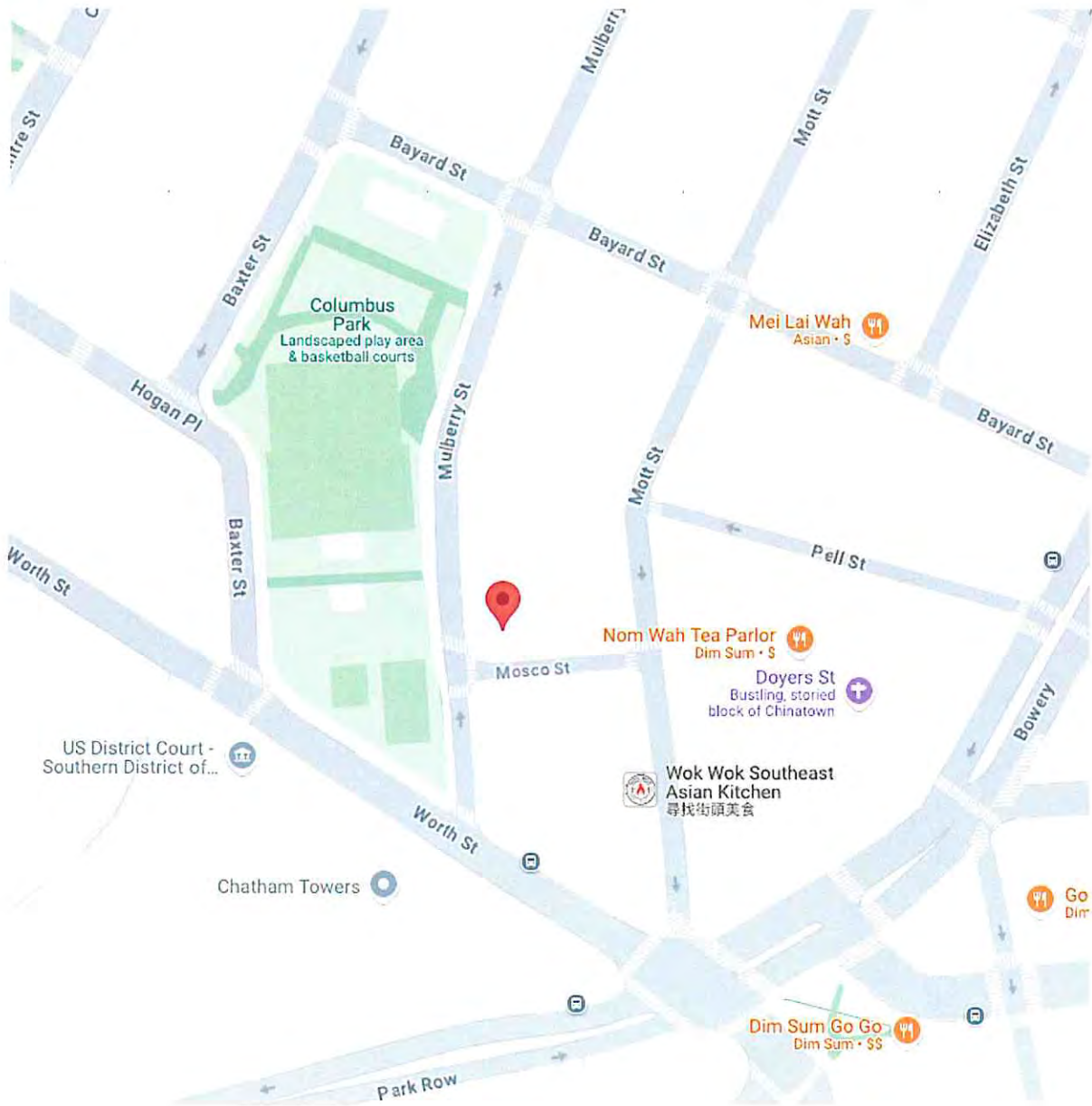

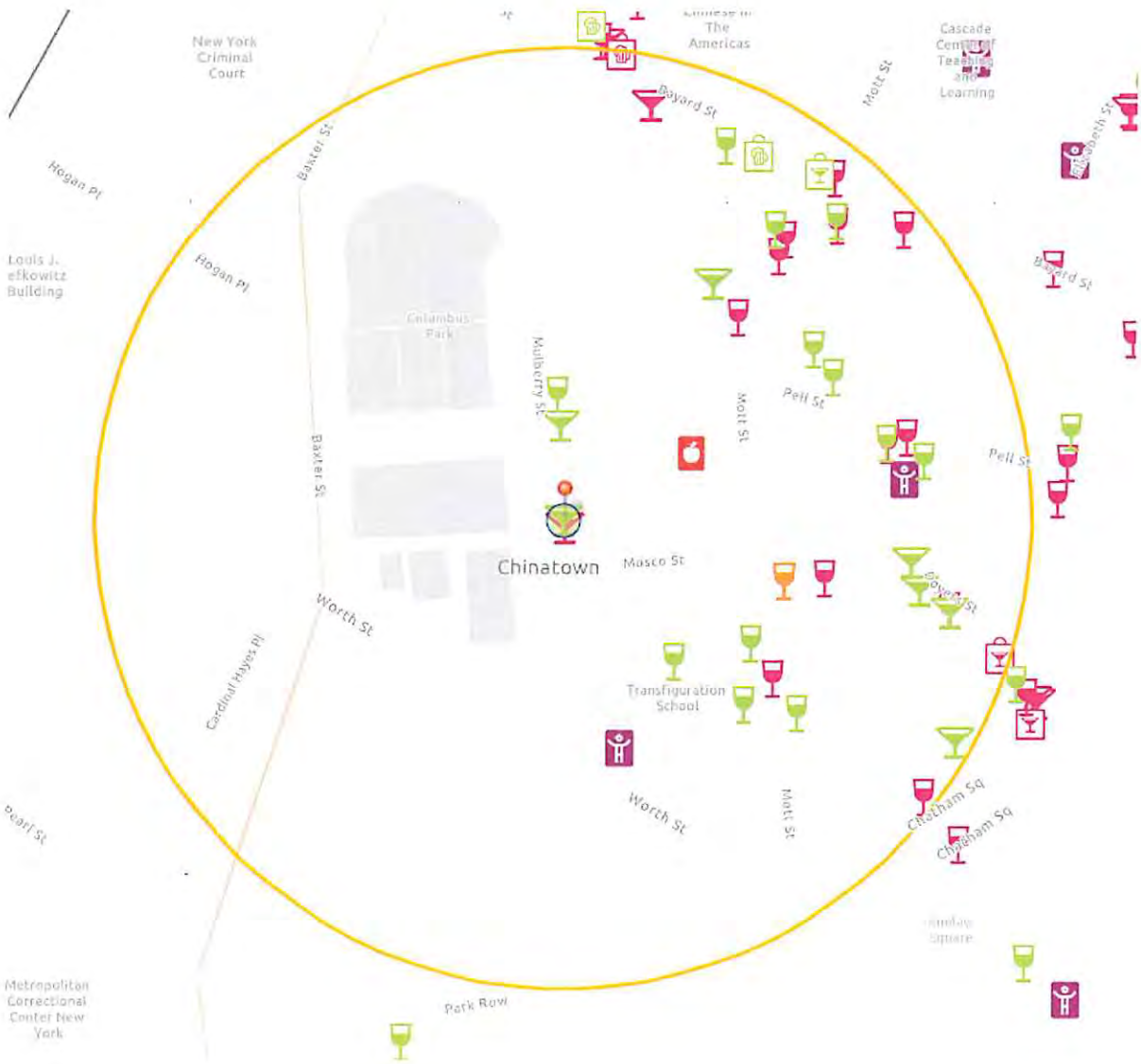
