

# HHS Cost Manual Update is Live!

The <u>HHS Cost Manual</u> has been updated! Please review the new provisions in Section III.

New provisions clarify that costs are unallowable if associated with a conflict of interest; cost allowability is limited to actual costs for less-than-arm's length agreements; and purchase of an interest or improvement of real property is unallowable, absent agency approval.
