## New Requirement for Public Work Contractors and Subcontractors

Starting December 30, 2024, contractors and subcontractors in New York City who are submitting bids or performing construction work on public projects must provide a copy of their **Certificate of Registration** from the New York State Department of Labor (DOL).

This new mandate ensures compliance with the recently enacted New York State legislation, Section 220-I of the Labor Law.

All contractors and subcontractors should register as soon as possible to avoid negatively impacting a bidding period or project schedule.



# The Power of Commodity Codes

Enrolling in commodity codes in PASSPort ensures that your business is accurately categorized which helps increase visibility to City buyers and access to relevant solicitations —making commodity codes a powerful tool for success.

#### **Best Practices:**

Enroll only in commodities related to goods and/or services your business provides (or can provide).

Review and update your commodity codes at least once a year.

Thank you for your patience and partnership as we navigate the rollout of the latest PASSPort release. We acknowledge the challenges post release and appreciate your patience and cooperation as we work to address them. We wanted to share progress and highlight key fixes that have been implemented:

- Vendors can now search and filter by 'Budget FY' on the 'Browse Contract Budgets' screen.
- Vendors can easily launch the contract workflow using the "Initiate Contract" button that is no longer missing.
- Purchase orders now process smoothly from "registered" to active status, allowing vendors to submit invoices and agencies to process advances.
- Advances can be initiated when there is a pending POCR. Please note the exception is when there is a de-cumbrance POCR.
- Vendors with specific profiles (Vendor Procurement and Vendor Financials roles) are able to now record payments and access subcontractor fields.

Council funding for any
fiscal year is not
guaranteed, even if you
have a registered multiyear
discretionary contract in
PASSPort.

## Digital Insurance Verification Pilot Launched!

In response to the Joint
Taskforce to Get Nonprofits
Paid on Time, the Vendor
Insurance Unit (VIU)
launched the Digital
Insurance Verification
(DIV) pilot with 65
participating vendors.

The pilot aims to accelerate contract registration, enhance the vendor experience, and reduce compliance risks for the City.

Results will be reported in 2025, and if successful, MOCS will consider citywide implementation.
