The Office of Temporary and Disability Assistance (OTDA) has further extended the deadline for submission of claims for replacement benefits from households impacted by electronic benefit theft. The date for submitting retroactive claims has now been extended until April1, 2024.

Households Eligible for to Submit Claims:

- Replacement benefit claims for SNAP benefits stolen between October 1,
 2022, and August 20, 2023, and Cash Assistance benefits stolen between
 January 1, 2022, and August 20, 2023 (retroactive claims) can now be
 submitted through April 1, 2024.
- The original retroactive claim form deadline was extended from October 31, 2023, to December 31, 2023, and has now been extended to April 1, 2024.
