Vieso (Cambria Heights): Ohel pilgrimage bringing hundreds of people to Cambria Heights. Senator Comrie: The messiah at this place for this sect of Jews. Proper social distancing and masks required. Police presence enough to manage these protocols. Wants neighborhood to be protected and safe. Therer is no way to put walls up to stop the pilgrimage.

BM Nantasha Williams: Is NYPD enforcing policies in other constituencies? Wants assurances. Brooklyn has had issues...

105 Precinct Report, Inspector Neteis Gilbert

- Crime down 13% (7 major)
- 5 shootings
- Domestic violence down 42%
- Quality of life (fireworks)
 - o A concern for everyone, affects sleep, pets
 - o Put out information on social media
 - o Need accurate information (specific location)
 - o Officer will respond but emergencies are prioritized
 - o ??? those distributing and selling fireworks

Annette McTear: Piggyback on Vernal's comments. 60-70 young men on grass in front of her home. Called 911 four times and it took more than 1 hour for a response.

Inspector Gilbert: What time?

Annette McTear: Started at 8:30 PM. Young men had boxes and boxes of fireworks.

Inspector Gilbert: Will look into it personally.

 Cars are not dispatched from the precinct. Call 311 or 911. Speak to NCO. Will modify tours to address this problem. Need location to have...

BM Marcia O'Brien: What steps would officers take when they arrive at fireworks scene? **Inspector Gilbert:** If they were young, confiscate the fireworks. Adults would be spoke to.
