- Clarification on Proposition B with Acting Chair picking Nomination Committee
- Discussion on process by Board Members on picking Nomination Committee
- o Chair wants vote on propositions
  - Since people want to form Nomination Committee
  - Clarification on Proposition B with who is on the ballot
- o Motion...

    - Wants a vote on both propositions
    - Roll call vote on an election
      - Motion: Lay over the election to a later date when the Board can meet in-person, by BM Bryan Block. BM Anup Ramnauth seconds the motion.
