- Applicant did not appear.
- Second invite will be sent.

BudBiz LLC applicant applying for an adult-use retail dispensary license at <u>44-37 Vernon Blvd.</u>, <u>LIC, NY (1<sup>st</sup> Invite)</u>

- Joseph Bondy, Esq. represented the Applicant.
- Jon Paul Pezzo, Salvatore Pinto and Giancarlo Pinto the Applicants attended the meeting.
- Upon entering the store, the customer would go through an ID check to see if they are over the age of 21.
- ID will be scanned.
- Armed security guard.
- The applicant will educate the customer on their products.
- The Applicant's intention is to follow the law.
- Upon entering the store the space is open and items are displayed along the wall or in a center cabinet.
- Security camera system for 24 hours.
- Hours of Operation: 7 Days till 12am
- Discussion on community employment at this establishment.
- They will be allowed according to the law to have up to 25 people working there for deliveries.
- The guidelines for delivery are very strict, you cannot deliver to a street corner, it has to be to someone's address.
- Every driver is tracked.
- No exchange of cash on deliveries.
- The product is locked in a saferoom and a fulfillment room.
- Applicant is encouraged to discourage smoking unless 25 feet from the entrance.
- Sidewalks should not be blocked by the delivery vehicles.

The stipulation will state their hours of operation, Hours of Operation 7 days- 8am to midnight, no cash to the delivery people, no smoking within 25 ft of the entrance and applicant should not block the sidewalks in anyway.

A motion was made not to oppose by Danielle Brecker and seconded by Caroline Spitzer.
