Stephen Cooper, Chair of the City Services & Public Safety Committee had a discussion with the committee regarding the outside restaurant sheds. Some are in use and some are not in use. Stephen Cooper mentioned that they should be inspected. The restaurants must go through DOT regarding the outside portion. Debra Markell Kleinert will discuss at her cabinet meeting requesting an update on the process of open restaurants and enforcement and how the approval process will work. CB2 will follow up. She mentioned if there are any sheds that are not being used or in disarray, the CB2 office should be notified. Danielle Brecker, CB2 Chairperson suggested mentioning at the next full CB2 board meeting that if anyone sees any restaurant sheds not being used to call 311 and call the CB2 office. DOT is working on this issue and is working with DCP. Debra Markell Kleinert mentioned that once she gets an update from DOT she will report back to the committee.

Stephen Copper mentioned the bike lanes and how DOT will be looking at this issue. He brought this up at the full board meeting. This will be investigated.

Stephen Cooper expressed to the committee that the City Services & Public Safety Committee should have questions prepared for the 108th Precinct. Debra Markell Kleinert suggested inviting someone from the 108th Precinct to a full board meeting. Warren Davis stated that the 108th Precinct Community Council has a monthly meeting and he will report back to the committee on the meeting.

The meeting was adjourned.
