NYS LIQUOR AUTHORITY MATTERS

LIQUOR, WINE, BEER & CIDER LICENSES – NEW APPLICATIONS:

- 1. Five Iron Golf LIC, LLC applicant applying for a Liquor, Wine, Beer & Cider License at <u>22-43</u> <u>Jackson Avenue, LIC, NY</u> (1st Invite)
 - Indoor golf concept for all ages.
 - Already located in three other places in the city.
 - M-F 6am to 11pm Sat. 7am to 12am Sun. 7am to 11pm
 - Food and Beverage component
 - Virtual golf experience.
 - Bar area with seating. 12 seats
 - A Full Kitchen.
 - Each bay area will be 16 ft. wide.
 - There are 7 bays at this location.
 - There is a couch and armchair in the bay area. Accommodate seating for 6.
 - 10 Tables with 30 seats disbursed among the bays.
 - Elevated American cuisine, flatbread, dips, sliders.
 - It's a condo building.
 - Background music will be primarily.
 - There will be live music occasionally.
 - There is soundproofing.
 - Ground floor is primarily entrance and stairs lead to the basement where establishment is.
 - No outdoor space.

A motion was made for no live music. Not to oppose the application. All were in favor with none opposed and no abstention.

 - Fusian American Restaurant Bar

 - Bar with 11 seats
 - No outdoor space or outdoor music.
 - Live Music, Dancing, background music, DJs for special events only.
 - 3800 sq. ft. on premises and basement basement is used for making of food and storage
 - Bierocracy was there before.
 - Studio building with artists.
 - 47th Road is closet residential area.

A motion was made to not oppose. All were in favor with none opposed and no abstention.

 - This applicant postponed.
- 4. Crystal Blue Party Hall and Theatre Inc. dba Majestic Hall applicant applying for a Liquor, Wine, Beer & Cider License at **55-70 58**th **Street, Maspeth, NY** (1st Invite)
 - Prior use was a dance hall.
 - This is a brand new application.
 - Location is manufacturing and industrial.
 - Commercial location with no residents.
 - Catering Hall, no public usage.
 - Working with 6 food vendors.
 - There will be security at these events.
 - They will work with a security company
 - 6 Tables 48 seats
 - 10 tables and 200 seats in large ballroom
 - Legal occupancy will hold 400 seats.
 - 10,000 sq. ft. in the premises.
 - Mostly DJ music.
 - Hours of Operation: Fri Sun. till 3am or 4am; Mon-Thurs till 11pm
 - Parking lot accommodates 30-40 spots and on street parking.
 - No promoters.
 - Original Name was Clinton Hall and was closed for a long time.

A motion was made to table and to invite the applicant back. A side visit will be conducted.

 - Hours of Operation: 5-7 days till 1am
 - No outdoor seating.
 - Speakers inside.
 - Multiple parking spots
 - Security outside.
 - This is the main floor.
 - 2nd floor is not completed.
 - Cosmetic reconstruction right now for a look at.

No vote this evening. More information needs to be sent from the applicant. There will be an on-site meeting conducted.

 - Half Bolivian half Peruvian Restaurant
 - Restaurant Wine License.
 - Hours of Operation: 7 Days till 4am
 - 74 in seating
 - Opened already.
 - Bar seating has 4 seats, maximum 6 seats.
 - All forms of entertainment live music, karaoke, DJ
 - They will have a sound limiter.
 - All necessary permits.
 - Outdoor seating.
 - Music outdoors till 10pm
 - Asking for 4am closure for Fri-Sun.
 - No objection for a committee member to visit this establishment.

A motion was made for a 2am closing as it is a new application and the motion was seconded. 500' rule to apply as there is a church nearby. It is also a residential area.
