Laura Shepard, Chair of the CB2 Environment, Parks and Recreation Committee Meeting welcomed everyone to the meeting.

Laura Shepard introduced Nick Gulotta to discuss the green infrastructure/porous pavement pilot in Sunnyside Gardens.

- Nick Gulotta is Councilmember Julie Won's Chief of Staff and reached out to the Environment Committee for a letter of support that the Councilmember's office has been advocating for DEP.
- Nick Gulotta mentioned that the councilmember's office gets a lot of complaints concerning flooding in the district. He talked about one area in Sunnyside Gardens concerning the flooding. The location of Skillman Avenue and 47th Street.
- DEP suggested a porous pavement project to help with this issue.
- Porous pavement is suggested when rain gardens cannot be placed in the area and the sidewalk is too narrow.

- DEP will be doing an assessment of this area. The assessment should be done this year. The project could take a two to three-year timeline.
- A discussion took place regarding DEP and their awareness of the areas that have flooding issues.
- Porous pavement is a longer-term investment, the city will maintain it and it doesn't take away parking.

Laura Shepard introduced Daniel Abram, New Yorkers for Parks.

- Daniel Abram is the Project Manager for Research and Policy at New Yorkers for Parks. (presentation is attached)
- They are the only independent advocacy organization for the parks department.
- Daniel Abram's spoke about supporting the 1% for parks campaign essentially it is asking for 1% of the Mayor's city budget.
- 1% of the City Budget for parks is specifically talking about the expense budget, this funding goes towards maintenance work and all the frontline staff that does that maintenance work.
- NYC spends less on parks than other major cities.
- NYC Parks have 1 gardener for every 114 acres, whereas San Francisco and Chicago have 1 gardener for every 18 acres.
- Daniel Abram, New Yorkers for Parks is looking for a letter of support from the community board.
- They presently have 45 letters of support from community boards.
- A support letter and resolution will be comprised and Laura Shepard made a recommendation to support 1% for Parks for language to go to the full community board.

QSWAB update:

- Benjamin Lucas gave an update on QSWAB.
- Composting was not discussed at QSWAB meeting.
- There was a presentation on waste management at Terminal 4 at JFK.
- There is some composting at the vendor areas.
- Food wastes is kept on site for one month before being transporting to another area.

Laura Shepard and committee had a short discussion on the compost collections and the sites of where there are no longer bins.

Laura Shepard made a motion to make a recommendation to DSNY to expand food scrap collection sites throughout the district. Either by siting more bins in a given zip code or suggesting specific sites that have demonstrated a need. In the letter it should state not only to restore but to increase the composting budget.

Laura Shepard made a motion to recommend that the city go forward with the porous pavement pilot program and equitably expand the program to other areas with a lot of severe flooding.

The meeting was adjourned.
