## June's Community Board Public Hearing/Meeting (recap) 183-02 Union Turnpike Fresh Meadows

• The Minutes of Wednesday May 10, 2023, were unanimously approved.

#### **♦** Chairperson's Report:

Chairperson Martha Taylor introduced the new Community Assistant, Soleil Griffin. She announced, Alan Ong has accepted the Chairmanship of the Youth, Library and Education Committee.

Community Board 8 is sending a letter to the NYC Department of Parks and Recreation in support of the plans to revitalize Goose Pond [Captain Tily] Park.

The Friends of Cunningham Park needs more volunteers.

◆ <u>Scott Solomon, Senior Borough Planner - Department of City Planning</u> — He gave a presentation regarding zoning for carbon neutralization, a non-ULURP text amendment. He distributed handouts detailing 17 proposed policies, sorted into four main goals for decarbonizing our energy through changes to buildings, transportation, water, compost, and recycling.

#### **Guest Speakers:**

## <u>Pascale Bernard, Deputy Director of Intergovernmental Affairs - NYS Office of Cannabis Management.</u>

- The Marijuana Regulation and Taxation Act (MRTA) was signed into law March 31, 2021. Legalizing a person over the age of 21 to smoke cannabis everywhere it is legal to smoke cigarettes and vape. They may buy and possess up to 3 ounces of cannabis flowers, up to 24 ounces of cannabis oil.
- Community Boards will monitor dispensaries and on-site consumption lounges.

#### The Honorable City Councilmember, James Gennaro

He will be meeting with other legislators about Medicare Advantage. Sandy's Law will not pass.

Local Law 97 is now the law of New York City. He proposes tax credits for compliance with Local Law 97; however, the City Council does not have the authority to pass this. He will be working with the city's Chief of Climate Officer. There are incentives for good faith property owners making an effort to comply with Local Law 97. Cooperatives and Condominium owners will be financially hurt while making these adjustments.

#### **Zoning Committee - Steve Konigsberg:**

Text Amendment N 230113 ZRY for The City of Yes for Carbon Neutrality

Chairperson Steven Konigsberg presented the joint Zoning and Housing/Buildings Committees' findings to the full Board. At the meeting, they reviewed the city's plan to move away from fossil fuel and how current zoning mandates impede progress. Tobias Paris made a motion in support of the Text Amendment, seconded by Dilip Nath.

#### **DEP/Sanitation Committee – Kevin Forrestal, Chairperson:**

Prior to this meeting, this committee's minutes were sent to every board member. The results of a community survey regarding "The Future of Trash" policy was emailed to all Board Members as well. The community rejected this policy. As a result, the committee drafted a letter to be sent to Mayor Eric Adams. Heather Bennett-Idels made a motion accept the letter, seconded by Susan Cleary. The motion unanimously passed.

#### <u> Area 6 Committee – Maria DeInnocentiis, Chairperson:</u>

Ms. DeInnocentiis thanked Chairperson Martha Taylor for her assistance with the Mayflower Hotel. The city wanted to extend the contract with Housing Works to continue to provide administrative support for three years, without public hearings. Community Board 8 along with elected officials, City Councilmember Linda Lee, State Senator John Liu and Assembly Member Nily Rozic were supportive of the concerns that residents voiced during this open contract period.

#### A Word from the District Manager

Dear Resident,

It is resurfacing season at Community Board 8!

You might have observed Department of Transportation contractors have milled [removal of the top layer] some of the streets in our community recently. They since have taken all their equipment and you are probably wondering when are they coming to finish the job. After milling, the department waits for about three weeks to resume the work by paving. Why? During these weeks, the agency gives other entities (i.e. Con Edison, Verizon, Spectrum, etc.) the opportunity to do work while the underlayer is exposed.

Once the street is resurfaced, there will be an embargo on street opening permits. This means only emergency work will be allowed. If work must be performed that will disturb the street, then the company will have to pay extra.
