PROTECT YOUR PIPES FROM FREEZING

Homeowners are responsible for protecting their pipes and water meters from freezing. Most pipes and water meters are in basements, crawl spaces, and other unheated areas, where cold winter temperatures could cause them to freeze.

If a meter freezes and breaks because the homeowner did not take reasonable steps to protect it, DEP will repair or replace the meter and bill the homeowner for the cost. If a service line or pipe freezes and breaks, it is the homeowner's responsibility to have repairs made by a licensed master plumber.

To protect your pipes and water meters from freezing:

- repair broken and cracked windows, doors, and walls
- install storm windows on basement windows
- tightly close doors and windows to the outside
- insulate outside walls
- eliminate drafts from crawl spaces
- turn off the water to outside faucets, remove hoses, and drain the pipes
- ask your local plumbing supplier about materials to insulate pipes and meters
- take extra care to ensure your meter is insulated if it is installed in an unheated garage
- insulate the wall and open cabinets if pipes or meters are in a closed cabinet against an outside wall to allow warmer air to reach them
- arrange to have someone turn on a faucet periodically if you are going to be out of town during cold weather.

If your pipes or meters freeze:

- 1. Open a faucet near the frozen point to release vapor from melting ice.
- 2. Direct a hair dryer or heat lamp at the frozen section, or put a small space heater nearby; and, **NEVER** thaw a frozen pipe or meter with an open flame. This is not only a fire hazard, but could also cause a steam explosion.

If you are unable to thaw the frozen pipes, consult a licensed master plumber. If your meter is damaged by the cold, contact 311.

Deputy Inspector Kevin Chan

Check stealing has been a growing national issue for several years. He suggested we use a pigmented pen to write checks. The thieves are fishing through mailboxes using string with a sticky substance at the end.

Honorable City Councilmember James Gennaro:

He introduced a new staff person, Mary Whitman. He announced that New York City is considering switching to the Medicare Advantage Plan for its retirees (a plan with lessor benefits than the current plan). The city would offer an improved plan option at the monthly cost of \$191.00. Advantage Plan would be paid for by the federal government for the next five years. The court informed the mayor's attorneys that the city administrative code does not allow for the mayor to make this adjustment. The only way to do this is for the City Council to rewrite the administrative code. Currently, the city pays 600 million dollars for retires and 700 million dollars for current employees.

He also stated that he is in favor of common-sense criminal reform.

Guest Speakers:

Suzanne Windland and Celine Dorisca: They represented Services Now for Adult Persons, Inc., the organization operates a senior center in Queens Village and provide services reaching beyond this location. The program includes transport services to the senior center, case management, meals on wheels, breakfast, lunch, fitness classes, bingo and services for persons exhibiting early to moderate stage of Alzheimer's disease.

Paul Graziano, City Planner:

He gave a presentation detailing Governor Hochul's proposed zoning plans.

- 1.Statewide cities would have to plan a three-year cycle to fast-track development of affordable housing units. If they fail to meet the quota the state will implement a plan without community board approval.
- 2. This year's proposal expands to include Metropolitan commuter railroad and subway stations in New York City and every area within a half mile. This would include all properties south of the Grand Central Parkway, Jamaica Estates, all of Kew Gardens and Richmond Hills and half of Northeast Queens.
- 3. All illegal property conversions would receive blanketed amnesty.

If a property has a A.D.U. (Accessory Dwelling Units) the property will be tax exempt.

Max Weprin, Representing QBP Donovan Richards

He announced that this will be his last meeting. He is leaving the Borough President's Office to take a position at the City Council. The Metropolitan Transportation Authority (MTA) announced switch replacement and Communications-Based Train Control (CBTC) related work will begin on the A, C, and S Avenue line during Presidents' Day weekend. This work will include replacement of tracks and switches north of 42 St – Port Authority Bus Terminal. As a result, there will be changes to service on the A, C, D, S and I lines beginning at 9:45 p.m. on Friday, Feb. 17 through 5:00 a.m. Monday, Feb. 27.

This critical work is being done over the holiday week to ensure minimal impact to customers. Due to the holiday, service will only be affected on four weekdays. Ridership on Tuesday through Friday that week has historically been 7% lower than typical weekday ridership.

Customers are advised of the following service impacts:

Uptown , , and trains will operate normally.

- Downtown trains will run express from 145 St to Canal St
- Downtown ¹ trains will run on the ¹ line from 5 Av/53 St to W 4 St
- Downtown trains will run local from 145 St to 59 St-Columbus Circle
- Select trains will operate via the line between Roosevelt Av and 47-50 Sts Rockefeller Center during *rush hours
- *Brooklyn-bound during morning rush hour, Queens-bound during afternoon rush hour
- trains will run via the , line between Delancey St-Essex St and Chambers St
- trains will terminate at Chambers St; no service between Essex St and Forest Hills-71 Av
- Downtown A trains will run express from 59 St Columbus Circle to Canal St at all hours, including late nights. Weekends and Presidents' Day Holiday
- Downtown trains will run express from 59 St Columbus Circle to Canal St
- Downtown ¹ trains will run on the ¹ line from 5 Av/53 St to W 4 St
- Downtown trains will run express from 59 St Columbus Circle to Canal St at all hours, including late nights

The City suspends alternate side parking regulations for both street cleaning purposes and traffic flow, on legal and/or religious holidays.




