In the original application, you were not supposed to be using the open space.

Are you utilizing the outdoor space?

Answer: [Sean Kim] – No.

Do you have a certificate of occupancy?

Answer: $[Jae\ Yu]$ – Yes. I have a copy (he provided the copy).

How many people can attend your restaurant?

Answer: $[Sean\ Kim] - 40 - 45$ people.

What are your hours of operation?

Answer: [Jae Yu] – Monday to Thursday 11a.m. – 10 p.m.; Friday and Saturday 11 a.m. – 11 p.m.; and Sunday 11 a.m. – 10 p.m.

How do you plan to handle underage drinking?

Answer: [Sean Kim] – Patrons have to show their ID.

Will your waitstaff be trained to check for fake IDs? Will there be certified training?

Answer: [Jae Yu] – One person will take the ATAP training. Then will train the others.

Do you have security or someone that is able to handle unruly customer?

Answer: [Jae Yu] – There will be no security guard since it is a restaurant. The staff will monitor the behavior of the customers. In case someone is making trouble, we would call the police.

How do you intend to keep the area cleaned?

Answer: [Sean Kim] – We would clean the street three times. When we open, in between operation and at the end of the day.

Will you have cameras set up?

Answer: [Sean Kim] – Yes.

Chairman Hannibal opened the meeting for questions from the Board Members.

Maria DeInnocentiis

You're close to a school across the street. I am sure kids come in for smoothies all the time after school. How will you ensure that the students will not go and buy a beer?

Answer: [Sean Kim] – The premise is not a smoothie place. It will be a Japanese restaurant.

Can you tell us what kind of restaurant you will be having?

Answer: [$Jae\ Yu$] – Mr. Kim took over the Japanese restaurant next to it. The property came with the equipment. He is operating the restaurant with a full liquor license. The fresh mix is not generating a lot of money. He has experience operating a Japanese restaurant. The Japanese restaurant is serving sushi. He decided to serve Japanese ramen.

I look forward to you opening a ramen restaurant.

What will be the name of your restaurant?

Answer: [Sean Kim] - Shobu Ramen

Will this be Koren or Japanese ramen?

Answer: [Sean Kim] – Japanese.
