Cannabis License Committee Chair Michael Hannibal called the meeting to order at 7:30 p.m. This was followed by self-introductions of all Board Members and staff.

#### **Purpose:**

This is to introduce the applicants to the Community Board to make them aware of the expectations of the board for businesses with on-premises liquor licenses. This establishment is applying for a full liquor license for a bar/lounge. Chairman Michael Hannibal asked the applicant and representative to state their names for the record. Applicant Ming Li and James Wong introduced themselves.

# Michael Hannibal

Will you have outdoor space? Answer: [James Wong] – No.

#### Michael Hannibal

What type of establishment will this be? Answer: [James Wong] – Restaurant

You're under the 75 people limit which means you do not require a certificate of occupancy.

**Answer**: [James Wong] – Yes

# Michael Hannibal

Your hour of operation shows a 12-hour shift Monday through Thursday – 11 a.m. to 11 p.m., and Friday and Saturday you are adding an hour – 11 a.m. to 12 a.m. Has that changed?

**Answer**: [*James Wong*] – No.

# Michael Hannibal

How do you intend to prevent underage driving? What type of training does your staff have?

**Answer:** [James Wong] – They will check their ID before they serve alcohol. If they find something unusual, they will stop serving alcohol.

# Michael Hannibal

What security measures will be taken? Will you have cameras?

**Answer:** [James Wong] –We will have cameras.

# Michael Hannibal

Is your staff familiar with any state tests that certifies a person to address drinking a security?

**Answer:** [James Wong]- Yes. Though I put in for a new application, this is a transfer. The staff has been there for 3 years. The ownership is changing.

# Michael Hannibal

How do you intend to maintain cleanliness in front of your establishment (i.e. smokers (ashtray))?

**Answer**: [James Wong] – Patrons can not smoke inside the establishment. They can smoke outside.

Mr. Hannibal opened the meeting for questions from the Board Members.

#### **Alan Ong**

Does your restaurant have a bar, or do you serve to the patrons who are dining?

**Answer**: [James Wong] – We are a restaurant, but we have a bar that has 10 seats.

# Alan Ong

Can people come into drink and not eat food?

**Answer**: [James Wong] – 95% of the patrons come in for food.

Committee member Marva Dudley stated that she will wave her time.

# Douglas Sherman

There is a smaller storefront next to the original storefront, will that be combined?

**Answer:** [Ming Li] – It used to be two stores.

**Answer**: [James Wong] – It was combined about four years ago.

# **Douglas Sherman**

Your capacity is still going to be 75 or under?

**Answer:** [Ming Li] - Yes.

**Answer**: [James Wong] – It would be about 50 people.

#### Douglas Sherman

What are your specialties?

**Answer:** [*Ming Li*] – Sushi.

#### **Michael Hannibal**

Can I have a motion to accept the application for a full liquor license for Ming's Asian Cafe located at 138-38/40 86th Avenue?

Motion made by Alan Ong and seconded by Douglas Sherman.

**Votes in favor**: Unanimous

# **Purpose:**

This is to introduce the applicants to the Community Board to make them aware of the expectations of the board for businesses with on-premises liquor licenses. This establishment is applying for a full liquor license for a bar/lounge. Chairman Michael Hannibal asked the applicant and representative to state their names for the record. Applicant Emanuel Pleshtiyev and Ariel Pleshtiyev introduced themselves.

# Michael Hannibal

How many people will be seated at your establishment?

**Answer**: [Emanuel Pleshtiyev] – There will be between 30 to 40 seating.

# Michael Hannibal

Does this also include people who may be standing at the bar?

**Answer**: [Emanuel Pleshtiyev] – There will be no standing at the bar just sitting.

# Michael Hannibal

Will it ever go over 75 people?

**Answer**: [Emanuel Pleshtiyev] – No.

# Michael Hannibal

What will be your hours of operation?

**Answer**:  $[Emanuel\ Pleshtiyev] - 5$  p.m. to 12 a.m. 6 days a week. We will be closed on Fridays and open after Sabbath on Saturday.

#### Michael Hannibal

How do you plan to handle underage drinking?

**Answer**: [Emanuel Pleshtiyev] – We are requesting ID.

# Michael Hannibal

Is your wait staff going to help with ID check? Will there be security?

**Answer**: [Emanuel Pleshtiyev] – Security will not be needed. There is one bartender that will be handling the liquor. They will be checking ID.

# <u>Michael Hannib</u>al

Will there be cameras?

**Answer**: [Emanuel Pleshtiyev] – We have installed cameras this past week. We have six cameras externally and four cameras internally.

Do you have a 30-day tape system?

**Answer**: [Emanuel Pleshtiyev] – It is on the cloud. It keeps running and we will have access to it on our phone.

# Michael Hannibal

Do you have a system in place to have a clean environment outside of the establishment?

**Answer**: [Emanuel Pleshtiyev] – There will be no smoking in nor outside of the establishment. There will be one personal that will be our full-time cleaning staff.

Mr. Hannibal opened the meeting for questions from the Board Members.

# **Douglas Sherman**

Has your building been recently renovated?

**Answer**: [Emanuel Pleshtiyev] – It is a brand-new development.

# **Douglas Sherman**

Are you taking a portion of the development?

**Answer**: [Emanuel Pleshtiyev] – Yes.

# **Douglas Sherman**

When do you plan to open?

**Answer**: [Emanuel Pleshtiyev] – Within a month.

# Israel Peskowitz

What is omakase?

**Answer**: [Emanuel Pleshtiyev] – It means we will leave it up to the chef. It is a type of culinary art that we do with high end sushi.

# Israel Peskowitz

Are your prices expensive?

**Answer**: [*Emanuel Pleshtiyev*] – No. We want to be affordable.

# James Gallagher

Will there be conflict with the synagogue across the street since you cannot sell alcohol within a certain feet?

**Answer**: [Emanuel Pleshtiyev] – No. It will be a very classy place.

# Michael Hannibal

Will the establishment fall in line with the 200 feet?

**Answer**: [Emanuel Pleshtiyev] – It is more than 200 feet away.

# **Alan Ong**

Is this your first business or first restaurant?

**Answer**: [Emanuel Pleshtiyev] – This is my first restaurant, but I have more businesses.

# James Gallagher

Is there another bar on the same side of the street?

**Answer**: [Emanuel Pleshtiyev] – There is a few. There is Cheap Shots, one that rebranded and Niko Sushi. We chose not to serve hard liquor; it is only for culinary purposes. Our establishment is for small family gatherings.

#### Marva Dudley

Is your restaurant reservation only?

**Answer**: [Emanuel Pleshtiyev] – In the beginning we will have first come first serve. We plan to make it reservation only to maintain the integrity of the brand.

When the reservations established the request for reservation be call in?

**Answer**: [Emanuel Pleshtiyev] – We will probably use Resy, Toast, Google panel or phone calls

**Michael Hannibal** 

Can I have a motion to accept the application for a full liquor license for Otoro NYC Corp., Inc. located at 179-24 Union Turnpike?

Motion made by Alan Ong and seconded by Douglas Sherman.

# **Purpose:**

This is to introduce the applicants to the Community Board to make them aware of the expectations of the Board for businesses with on-premises Cannabis licenses. This establishment is applying for a Cannabis License for a Retail Dispensary Premise. Applicant Manjit Kaur introduced herself.

# **Michael Hannibal**

What is your role in this establishment?

**Answer**: [Manjit Kaur] – I am one of the owners. The co-owners are my mother and my brother.

# **Michael Hannibal**

This is a family-owned business.

**Answer**: [Manjit Kaur] – Yes.

# **Michael Hannibal**

What is your history with the product? Why did you choose a cannabis retail dispensary?

**Answer**: [Manjit Kaur] – I do not have experience with cannabis. I have used CBD oil and concentrates that have been good for pain, anxiety and sleep. My brother motivated me to get into this business with him.

# Michael Hannibal

Are you using this as an opportunity to employee people in the community?

**Answer**: [Manjit Kaur] – Yes. I have seen people's experiences with illegal smoke shops. We want to create awareness around the product and employ people in the community.

# Michael Hannibal

What is your professional background that brought you on this journey?

**Answer**: [Manjit Kaur] - I am a practicing attorney. My mother and brother co-own a pizza shop in Floral Park. They have been running since 2008.

# **Michael Hannibal**

What type of cannabis?

**Answer**: [Manjit Kaur] – Different strains of flower, CBD products, concentrates, oils, edibles, vapes, etc.

#### **Michael Hannibal**

What will be the THC levels?

**Answer**: [Manjit Kaur] – That is regulated by the state. You can only have a certain amount since it is taxed.

How are you from any type of school or house of worship?

**Answer**: [Manjit Kaur] – We are over a thousand feet from any school and five hundred feet from a place of worship.

# **Michael Hannibal**

What would be the hours of operation for your establishment?

**Answer**: [Manjit Kaur] – Monday through Friday 10 a.m. to 10 p.m., Saturday 9 a.m. to 11 p.m., and Sunday 10 a.m. to 9 p.m.

# **Michael Hannibal**

How do you plan to address underage patrons? What security/protocol do you have in place for that?

**Answer**: [Manjit Kaur] – We will have at least two security personnel. Our staff will be trained to identify fake IDs and we will also have ID scan technology. We will also have signage posted.

# Michael Hannibal

Will your staff have training on cannabis?

**Answer**: [Manjit Kaur] – Yes. They will have training in the product safety and background in the science of cannabis.

#### **Michael Hannibal**

In terms of loitering, there will be no person smoking in front of the establishment.

**Answer**: [Manjit Kaur] – No. We did not apply for a consumption lounge. Patrons are to purchase the product and leave.

#### **Michael Hannibal**

How do you see your security handling a patron who purchases an item and consumes the product outside the establishment?

**Answer**: [Manjit Kaur] – We will have clear signs and ensure that our security is enforcing the no loitering. We have surveillance cameras and will monitor activity outside the establishment.

#### **Michael Hannibal**

In terms of loitering, there will be no person smoking in front of the establishment.

**Answer**: [Manjit Kaur] – No. We did not apply for a consumption lounge. Customers are to purchase the product and leave.

# **Michael Hannibal**

Have you communicated or established any communication with the 107th precinct?

**Answer**: [Manjit Kaur] – No. We are still finalizing our deal with the business.

Mr. Hannibal opened the meeting for questions from the Board Members.

# **Alan Ong**

Is there a smoke shop by the pizza shop and down the block?

**Answer**: [Manjit Kaur] – Yes. There is one on our block. I am not certain about the other shop.

# James Gallagher

Is there parking in the back for you?

**Answer**: [*Manjit Kaur*] – Yes. There are a few spots in the back. If parking becomes an issue, I plan to speak with the local businesses for the larger lot.

#### **James Gallagher**

Have you met the owner of the commercial complex?

**Answer**: [*Manjit Kaur*] – No.

# **Marva Dudley**

Will your establishment be selling pre-rolls?

**Answer**: [Manjit Kaur] – Yes.

# **Douglas Sherman**

Are you a cash only business?

**Answer**: [*Manjit Kaur*] – No. There are now cannabis friendly banks. We also have a point of sales system. Our bioonline track system is implemented with our point-of-sale system. We are required to have a vault. Our product is in display cases.

# **Douglas Sherman**

How do you sell the product?

**Answer**: [*Manjit Kaur*] – Our buy online pick-up in store system will streamline the process of having a lot of people coming in. Majority of customers know what they want. We would only have a few people who would work with a sales associate to look at the product.

# **Israel Peskowitz**

What is bio tracking?

**Answer**: [*Manjit Kaur*] – It is a system that the state has regulated that track where the product is grown, where it delivered, and sold.

# **Michael Hannibal**

Where are you at in the stage of opening your establishment?

**Answer**: [Manjit Kaur] – We are finalizing the deal on the space. We have a lease. It is still a sandwich shop, and we need to convert it.

# **Michael Hannibal**

Can I have a motion to accept the application for a retail dispensary permit for Lotus Dispensary, Inc. d/b/a High Road located at 185-24 Horace Harding Expressway?

Motion made by Alan Ong and seconded by Douglas Sherman.

**Votes in favor: Unanimous** 

Board Members who voted in favor: Michael Hannibal, Marva Dudley, James Gallagher, Alan Ong, Douglas Sherman.
