#### Community Board 8, Queens Board Meeting held on Wednesday, March 19, 2014 at 7:30 p.m. Hillcrest Jewish Center, 183-02 Union Turnpike

The minutes of the February 12, 2014 meeting were approved. 31 in favor, 0 opposed, and 0 abstained.

<u>Congresswoman Grace Meng</u> brought to our attention a scam called "spoofing." That is when a caller tricks the caller I.D. so that it appears that you are receiving a call from a governmental agency. That is used to scam people out of money. There is no law making this illegal if the call is made out of the country or if it is a text message. She is looking to make this practice illegal. She also announced that she co-founded the Kids Safety Caucus.

<u>Guest Speaker – NYC Comptroller Scott Stringer</u> informed us that as auditor in chief for the City of New York, he conducted an audit of the NYCHA. He is working to streamline the overdue repairs. He also audited the three library systems of New York City, as over 80% of their budgets come from public funds. As Comptroller, he oversees over 20,000 City contracts. He is making sure that the City is not being abused with cost overruns. He also introduced his Community Liaison Pesach Osina who will be representing him at CB8 meetings.

<u>Councilman Rory Lancman</u> informed us that he participated at a City Council hearing with the Department of Environmental Protection. He inquired about the flooding problem on Utopia Parkway. He also raised concerns about the increase in water rates every year.

<u>Chairman Alvin Warshaviak</u> announced the retirement of Barbara McKeon. He also announced that Community Service Aide Alma Karassavidis has been promoted to the full time position of Community Assistant.

<u>Assistant Chief Michael Barrere</u> was introduced. He is available to come to community meetings and to assist the community. He discussed "stop, question and frisk" and encouraged the residents to contact the Precinct Commander, CCRB and his office if there are any issues on this matter.

<u>Commanding Officer Fredrick Grover</u> reported on the 107th Precinct's activities. All major crimes are down. A drugs dealer was apprehended following a noise complaint. He discussed the success of the graffiti clean-up in the area

# A Word from the District Manager ...

Dear Resident:

When catch basins are covered with debris, it poses a problem for neighboring properties. When it rains, the debris will prevent rainwater from flowing freely into sewers. While the Department of Environmental Protection cleans catch basins on a schedule, residents can help.

Homeowners can help by maintaining their sidewalks and curbs. Especially by cleaning eighteen inches into the street from the curb. In doing so, they must be mindful not to allow debris to enter the sewer system through the catch basins.

As the temperature rises, you will probably take a stroll or two in your neighborhood. If you notice that catch basins are covered with leaves or debris or any other defect, please file a complaint. Call us at Community Board 8 during business hours or 311 at other times. Last year, with the help of civic minded residents, like you, the Department of Environmental Protections was alerted to a slew of catch basins that needed repair and clean-up in Flushing Heights, a neighborhood in Community Board 8.


If everyone does a small part, our City will be the best. It takes more than City Hall to make New York City great, it takes us all!

#### PASSOVER/PESACH SAFETY TIPS

- **Bedikat Chometz** (searching for Chometz)
  - A. Keep the candle away from flammable objects, especially curtains, sofas, tablecloths.
  - B. SUPERVISE children closely at all times
- Never allow children near boiling water when cleaning for Pesach. Adults need to take extra precautions
  at this time as well.
- Be aware that oven cleaners cause severe burns. Be extremely cautious when using these products.
- Always turn pot handles inward to keep pots from being pulled down by a child or knocked off by an adult.
- Keep Yom Tov, Shabbes and Yahrzeit candles on sideboards, out of the reach of small children. If the
  candles are on the table, keep them in the center where they are less likely to be pulled down by a small
  child.
- Burning Chometz
  - A. Do not bring **moist Lulavim** to burning stations(They don't burn and extinguish the fire)
  - B. Do not bring entire loaves of bread and large quantities of other items to burning stations.
  - C. <u>Do not wrap chometz in plastic or aluminum foil</u>. Plastic fumes are toxic and aluminum will prevent the chometz from burning.

The weeks prior to Pesach/Passover is a high scald and burn time within the Jewish community.

Special burn prevention care needs to be taken at this time.

A person who owns, or controls a dog may not allow it to be in any public place or in any open or unfenced field abutting a public place, unless the dog is effectively restrained by a leash or chain no more than six feet long.


