The Minutes of the February 12, 2020 Board Meeting were unanimously approved by 27 members.

Chairperson Taylor expressed her condolences to Board Member Mary Maggio on the passing of her daughter, Lauren. Chairperson Taylor announced that the Community Board needs to have a contact person and telephone number for each Board Member in case of an emergency. The information will be kept confidential at the office.

Guest speakers: Tejumade "Teju" Ajaiyeoba – Ms. Ajaiyeoba gave a brief overview on the Coronavirus. She explained Coronaviruses: a set of viruses which run from mild to a common cold. This may include something more severe, like a pneumonia. What they are dealing with now is a "Novel Coronavirus". It is referred to as "Novel" because it is new. It has been abbreviated to COVID-19. Some of the symptoms associated with this virus are fever, cough and shortness of breath. In terms of prevention, the agency suggest that individuals cover their coughs and sneezes. Use your elbows or sleeves, not your hands. Wash your hands for at least 20 seconds. Wash hands often with soap and water or use an alcohol-based hand sanitizer.

### NYC Department of Parks and Recreation

In response to observed crowding at certain Parks sites, and as part of the city's ongoing effort to maintain social distancing in public spaces to keep all parkgoers safe, NYC Parks will close the following facilities effective immediately:



- Volleyball courts
- Bocce courts

Additionally, adult fitness and exercise equipment areas in parks will be carefully monitored, and NYC Parks will close these areas where necessary to prevent crowding.

Areas of parks outside of these features will continue to remain open for park visitors to enjoy. The citywide enforcement effort to encourage social distancing among parkgoers remains in place, involving multiple City agencies, including NYPD, OSE, the Sheriff's Office, DEP, DSNY, DOB, and FDNY. The City will continue to monitor conditions and determine if more severe restrictions are necessary.

To make it easier for New Yorkers to enjoy their parks and benefit from recreational opportunities, even if they're staying indoors, NYC Parks has launched **Parks@Home**: a wide variety of online park tours, fitness classes and other fun activities. **Doraine Zhong, Government Affairs Officer, DFTA** – Ms. Zhong announced that the agency just launched a new information center for seniors. It is called, "Aging Connect". Aging Connect is the City's direct link to aging services. For more information, please call: 212-AGING-NYC (212-244-6469) to speak with an aging specialist and learn about services and supports available for older adults and their caregivers, and volunteer opportunities. She introduced Ms. Elizabeth Sofield, Program Director, NY Foundation for Seniors Citizens – who spoke about the Home Sharing program.

This program was established in 1968. It is a program that connects adults "hosts" with extra private spaces in their homes or apartments with appropriate adult "guests" to share their space. A "host" is a person who has a spare bedroom in their private home or apartment willing to share it with someone in order to share costs. The guest is on a monthly contribution. They are not on a lease, they are on a licensed agreement. They go through a screening process: background check, photo I.D., proof of income, etc. They have social workers who conduct social visits to make sure that the homes are suitable for the guests. ### **Committee Reports:**

Kevin Forrestal, Co-Chair - Queens Complete Count Committee (QCCC) – He informed us that starting tomorrow, March 12th, mailers will go out to households with questionnaires to fill out for the Census. He encouraged everyone to fill it out. He wants to make sure everyone gets counted. He reminded everyone that the information that they provide is confidential and it is prohibited by law from being distributed. At their last QCCC meeting, there were presentations on what the Library system is doing to assist in the NYC Census and other City and State entities are doing.

Bhitihara Martha Fulton, Chair, Parks Committee – The committee met on February 18, 2020 to discuss a proposal from the NYC Soccer Initiative and the creation of mini soccer fields in several playgrounds in our District, and to review the Flushing Meadow Corona Park Meadow Lake paths project. The Mayor's Fund to Advance New York City, is a not-for-profit organization committed to promoting partnerships between the City and the private sector in support of high impact public programs. This initiative is a five-year initiative funded with \$3M. The goal is to install 50 soccer pitches with free programming and maintenance fund or \$600,000 dollars. These areas have not been utilized and the space can be used for this purpose. This program will operate 24 weeks out of the year. The proposed pitch areas for Community Board 8: Utopia Playground, Pomonok Playground/P.S. 201, Fresh Meadows Playground/P.S. 173Q. They all sit in an empty area of yard which is not really being utilized. The installation process will take about three to six weeks. A vote was taken for a letter of support to be sent. Vote: 25 in favor 2 Opposed 0 Abstained

Meadow Lake NW Path Project – This project is a \$3.72M budget. The goal is to simplify and clarify existing pedestrian circulation, reduce the impacts of frequent flooding, improve entrances at the pedestrian bridges and create safe crossings at pedestrians/vehicular intersections. A motion was made at the meeting to approve the plans for this project to be done at Flushing Meadow Corona Park.

**Honorable** [Acting] **Borough President Sharon Lee** – Borough President Lee took the time to thank the full Board for their support during her transition as acting Borough President. She has enjoyed this journey and is forever grateful with the Borough of Queens for the support given during this time. She reminded everyone that we have elections coming up. She encouraged everyone to vote and to fill out the Census questionnaire.

## Have you tried to buy any good or service needed to limit the spread of COVID-19?



On March 16, the NYC Department of Consumer and Worker Protection (DCWP) announced an emergency rule that makes price gouging illegal for any personal or household good or any service that is needed to prevent or limit the spread of or treat the new coronavirus (COVID-19).

### Examples include:

- Cleaning products
- Diagnostic products and services
- Disinfectants (wipes, liquids, sprays)
- Face masks
- Gloves
- Hand sanitizer

- Medicines
- Paper towels
- Rubbing alcohol
- Soap
- Tissues

It is illegal to increase prices of these types of goods and services by 10% or more.

### Were you overcharged?

If you think a store excessively increased the price of these items beginning in March, file a complaint at nyc.gov/dcwp or call 311 and say "Overcharge."

### Reminder about NYC's Paid Safe and Sick Leave Law

If you work part time or full time at any size business or nonprofit in NYC, you have the right to safe and sick leave to care for yourself or anyone you consider family.

## COVID-19 PAID SICK LEAVE



## **EMPLOYEES**

Under legislation signed by Governor Cuomo, New York workers are guaranteed job protection and financial compensation while they are on a mandatory or precautionary quarantine order due to COVID-19.

## YOU ARE ENTITLED TO THE FOLLOWING PROTECTIONS AND BENEFITS IF YOU ARE SUBJECT TO A MANDATORY OR PRECAUTIONARY QUARANTINE ORDER:

If you work for a business with 10 or fewer employees and it had a net income less than \$1 million last year you are entitled to:

- Guaranteed job protection for the duration of the quarantine order.
- Paid Family Leave (PFL) and Disability Benefits (DB) through your employer's existing policy.
   You will receive your salary up to a maximum of \$2,884.62 per week for the duration of your mandatory or precautionary quarantine.

If you work for a business with 10 or fewer employees and it had a net income greater than \$1 million last year you are entitled to:

- At least 5 days of paid sick leave and guaranteed job protection for the duration of the quarantine order.
- After these paid sick days, you are eligible for PFL and DB through your employer's existing policy.
   You will receive your salary up to a maximum of \$2,884.62 per week for the duration of your mandatory or precautionary quarantine.

If you work for a business with 11-99 employees you are entitled to:

- At least 5 days of paid sick leave and guaranteed job protection for the duration of the quarantine order.
- After these paid sick days, you are eligible for PFL and DB through your employer's existing policy.
   You will receive your salary up to a maximum of \$2,884.62 per week for the duration of your mandatory or precautionary quarantine.

If you work for a business with 100 or more employees you are entitled to:

- Guaranteed job protection for the duration of the guarantine order.
- At least 14 days of paid sick leave.

If you work for a public employer (no matter the number employees) you are entitled to:

At least 14 days of paid sick leave.

### IMPORTANT NOTES:

- If you are quarantined but are able to work from home you do not qualify for these benefits.
- If your business is closed due to COVID-19, your employees may immediately apply for Unemployment Insurance.
- You may be eligible for additional leave under PFL and DB. Please call the hotline for more information.

## Did you know???



In accordance with State Executive Order 202.6 and the subsequent Empire State Development Corporation guidance, all non-essential construction is suspended for the duration of this state of emergency. Exceptions are provided for the following:

- Construction work necessary to protect the health and safety of occupants;
- Construction work necessary to make a site safe in advance of suspension;
- Construction work that is limited to a single worker;
- Construction work related to utilities, hospital/healthcare facilities, transitional and affordable housing.

If you notice construction outside of these exceptions, please file a complaint through 311 or contact Community Board 8.

### **Con Edison**

The utility company will not disconnect anyone's utility service due to non-payment. The company encourages customers to call and make arrangements.

Con Edison will not call anyone on the telephone and ask them to make payments. **Avoid Scams**. All payments over the telephone should be initiated by the customer by calling the telephone number listed on your utility bill.
