- ♦ The Minutes of the October 22, 2014 Board Meeting were unanimously approved by 40 Members
- Chairman Alvin Warshaviak offered condolences to Board Member Seymour Schwartz on the passing of his wife Zorya. He also offered condolences to Alan Beerman on the passing of his mother, Toby Beerman.
- ♦ <u>Assemblywoman Nily Rozic</u> reminded the residents of the new speed limit. She announced that a Speed Sign was posted outside Holy Family Church on 75<sup>th</sup> Avenue temporarily to slow down the 75<sup>th</sup> Avenue corridor.
- Public Safety Committee Chair Mark Lefkof reported on the state of NYPD, FDNY, and EMS in Community Board 8. The three firehouses in the jurisdiction of Community Board 8 (Union Turnpike, Utopia Parkway, and Hillside Avenue) all have major structural or electrical issues that need to be addressed. Public Safety Committee Chair Lefkof requested that a strong letter be sent to our elected officials to have the issues addressed.
- ♦ BSA Calendar No. 226-14-BZ, 147-02 76<sup>th</sup> Road, Flushing, NY The applicant was seeking permission to construct a Synagogue at that location which would consist of a three (3) story use group 4 synagogue, associated religious school and Rabbi's office.

♦ BSA Calendar No. 35-10-BZ, 144-11 77<sup>th</sup> Avenue, Flushing, NY - This application did not seek to construct a building. The building was previously constructed. This application sought to permit proposed changes to the BSA previously approved plans. Minor changes were proposed, along with an extension of the one year time period to obtain a Certificate of Occupancy.

### $oldsymbol{A}$ Word from the District Manager $\dots$

Dear Resident:

During the 2014 Holiday Season let's make New York City the best place to live by following these rules and even go the extra mile by being a good neighbor:

- The Sanitation codes require that snow be removed from the sidewalks within 4 hours after the snow has stopped falling, or by 11:00 a.m. if the snow has stopped falling after 9:00 p.m. the previous evening. In addition, snow may **NOT** be thrown into the street. If the snow or ice becomes frozen so hard that it cannot be removed, the sidewalk may be strewn with ashes, sand, sawdust, or similar suitable material within the same time limits. The sidewalk must be thoroughly cleaned as soon as the weather permits.
  - As a good neighbor, you can also make a path for your elderly neighbor or for your neighbor with special needs. The Fire Department recommends clearing the hydrants of snow and ice as well this can save a life.
- The Sanitation codes require that each person who owns, or controls a dog must remove any feces left by that dog on any sidewalk, gutter, street, or other public area and dispose of it in a legal manner. The person may remove the feces and carry them away with him/her for disposal in a toilet or place them in a non-leaking container or bag and deposit them in a DSNY litter basket. The provisions of this law do not apply to a guide dog accompanying any blind person.
  - As a good neighbor, do not dump the feces in your neighbor's garbage pail or his recycling bin. Take it with you and dispose of it in your own trash can.
- The Sanitation codes require that when using a "blower" for grass, leaves, litter, etc., it must be blown into a pile and properly disposed of with other sweepings. If you hire a landscaping service, the company is required to take the leaves, grass clipping and other yard waste and to dispose of them according to DSNY regulations. It cannot be put out for DSNY collection. As a good neighbor, do not blow leaves, grass clippings and other debris onto your neighbor's property and do not sweep it into the catch basins. The Department of Environmental Protection recommends keeping the catch basins clear of leaves and debris. Clogged catch basins contribute to street flooding.

This is the season for sharing. Please share our Newsletter with a neighbor and encourage him/her to receive his/her own copy. Remember... It takes more than City Hall to make New York City great, it takes us all!

## Did you know???



Dogs must be on a leash (no more than six feet long) at all times [in NYC Parks], except in designated off-leash areas at prescribed times. Designated off-leash areas are:



<u>Designated Off-leash Areas:</u> Certain park areas allow dogs to be off-leash from the time the park opens until 9 a.m., and from 9 p.m. until the park closes. For a complete listing of sites, please visit: www.nyc.gov/parks/dogs

Dog owners/attendants with dogs off-leash in these designated areas must obey all general rules, including having their dog under control at all times, licensing the dog, and carrying proof of the dog's rabies vaccination.

Not Knowing the difference between No Standing, No Parking and No Stopping can be costly:


