Dear Community Board 8 Resident:

Did you know that August is the National Breast Feeding month? Did you know that breastfeeding is best for you and your baby? According to the Department of Health breastfeeding offers many benefits to you (the mother) and to your baby.

Here are the benefits to your baby:

- Breast milk is filled with the vitamins and nutrients that your baby needs. It builds your baby's immune system and helps their brain develop.
- Breast milk is easier to digest than formula, resulting in less spit-up and diarrhea.
- Breastfed babies are less likely to become obese later in life.
- Breastfed babies are less likely to get infections and to develop SIDS (sudden infant death syndrome), asthma, diabetes and other chronic conditions.

Here are the benefits to you:

- Breastfeeding helps your body recover from pregnancy and labor shrinking your uterus back to size and reducing bleeding after birth.
- Breastfeeding lowers your risk of getting diabetes, ovarian cancer and some forms of breast cancer.
- Breastfeeding helps you bond with your baby.
- Breastfeeding saves time. No bottles need to be washed and sterilized. Most of all, it is FREE.

A Message from The Department of Environmental Protection

Opening fire hydrants without sprinkler caps is wasteful and dangerous. Illegally opened hydrants can lower water pressure, which can cause problems at hospitals and other medical facilities and hinder fire-fighting by reducing the flow of water to hoses and pumps. Children can also be at serious risk, because the powerful force of an open hydrant without a sprinkler cap can push them into oncoming traffic. **Call 311 to report an open hydrant.**



Hydrants can be opened legally if equipped with a City-approved sprinkler cap. One illegally opened hydrant wastes up to 1,000 gallons of water per minute, while a hydrant with a sprinkler cap only puts out around 25 gallons per minute. Visit your local firehouse to have a sprinkler cap installed.





The animal abuse registry is now active. Information about the registry is here: http://www.nyc.gov/html/doh/html/environmental/animal-abuse-registry.shtml. You'll see that convicted animal abusers are directed to contact the Department to set up the in-person registration appointment via 311 or by email. Our General Counsel's Office will conduct the registrant interview and maintain the registry. The animal-related businesses and organizations ("authorized entities" under the law) will be provided with password-protected access so they can check the registry before transferring ownership of an animal.

We are sending letters to the district attorneys in the five NYC counties, the New York State Chief Judge, the New York State Division of Criminal Justice Services, and the major public defender offices to let them know about the requirement to register, how they can access the registry and how to contact us if they know someone required to register. We are also sending letters to the authorized entities to notify them about their obligations under the Local Law and how to subscribe to the registry.
