## Community Board 8, Queens Board Meeting held on Wednesday, November 13, 2013 at 7:30 p.m. Hillcrest Jewish Center, 183-02 Union Turnpike

- The minutes of the October 9, 2013 meeting were approved.
- Chairman Alvin Warshaviak announced with much chagrin the death of former Community Board 8 **Chairman Al Daly\***. He also announced the resignation of Board Member Norma Stegmaier from the Board after serving for 25 years.
- <u>ULURP No. 120178ZMQ</u> Proposal to rezone 158-15 Union Turnpike from R2-3/C1-2 to R5D/C1-3. This would allow the construction of a mixed used four-story building with stores on the first level and residential apartments on the other levels. This would cap the maximum height to 40 feet. A pre-existing curb cut on Union Turnpike will allow the entrance on there.

Vote: <u>17</u> in favor <u>14</u> opposed <u>0</u> abstained

## A Word from the District Manager ...

Dear Resident:

Many of you are right in the middle of holiday shopping. While you are selecting presents for the young and old to spread holiday cheer others are watching you. They are waiting for the opportunity to steal your goods, cash and credit cards. In addition, there have been reports of telephone scams to look out for. Here are a few tips from the NYPD to avoid being a victim:

- Be alert and aware of your surroundings at all times. Criminals often target people who are distracted.
- If possible, stay in designated waiting areas or in view of the station booth clerk while awaiting your train. Never walk or stand near the edge of the subway platform.
- Travel on populated, well lit streets. If possible, travel with a friend.
- When driving, keep your doors locked and the windows closed. Make sure the gas tank is full. Maintain your car in good working order to avoid breakdowns.
- Always lock your car. Before getting into your car, check the back seat to make sure no one is hiding there.
- Avoid leaving valuables in your car. Whenever possible, place items out of sight in the trunk of your vehicle prior to reaching your destination. Never leave packages in the passenger compartment unattended.
- Plan your purchases in advance and carry only the amount of cash or number of credit cards necessary to make the purchase. If you must carry a large sum of money, divide the cash between your purse, pockets and wallet.
- Cancel credit cards you don't use and keep a record of the account numbers for each credit card you possess. This will facilitate reporting the theft or loss of the cards.
- Carry your purse close to your body. Place one end of the purse in the palm of your hand and the other in the bend of the elbow. Never wrap the strap around your body.
- If you are carrying a wallet, carry it in the breast pocket of your jacket or in your side pants pocket. The rear pants pocket is the easiest to pick.
- When in a restaurant, don't leave your handbag over the back of your chair or on the floor. Don't leave your belongings unattended.
- Don't wait until you have reached your front door to look for your keys. Have them ready in your hand. If a stranger is standing near your door, it may be a good idea not to go in until the situation feels safer. Lock your front door immediately upon entering your home.

According to the 107th Precinct, you must also beware of people calling on the telephone and asking you to wire money. The target victim of this scam is called by someone claiming to be a relative who needs bail money to get out of jail. Or they may claim your family member has been kidnapped and will demand that the ransom be paid via a money transfer service such as Western Union. Keep in mind that anyone calling and asking you for money MUST be considered suspicious.

Here are some steps to take if this occurs:

- Hang up the phone.
- Remain calm and contact your loved ones to verify their safety.
- Never wire money in a panic.
- Never give your personal or financial information to the caller.
- CALL 9-1-1

I urge you to use these safety tips from the New York Police Department. The Community Board 8 staff joins me to wish you a joyous, healthy, peaceful and crime free holiday season!

## A Word from the Taxi and Limousine Commission....


New York City Boro Taxis

On June 6th, 2013, the Taxi and Limousine Commission (TLC) began issuing licenses for a new type of taxicab called a Boro Taxi. The drivers of these cabs can provide safe, legal street hail service to passengers in northern Manhattan, Brooklyn, Queens, The Bronx, and Staten Island. If you haven't seen one in your neighborhood already, you should be seeing one in the coming months.

Here are some key facts the TLC wants you to know about Boro Taxis:

- <u>Areas of Service</u>: You can hail these taxicabs anywhere within the five boroughs except in Manhattan below W.110<sup>th</sup> Street and E.96<sup>th</sup> Street. You can also call ahead for one from your local car service.
- <u>Set Fares:</u> If you hail one, your driver has to use the metered fare, which is the same as the
  yellow taxi rate. If you call your local car service for one, the driver must input the car service's
  fare into the meter.
- Convenience & Customer Service: All Boro Taxis will be green in color, have a rooflight to
  indicate if it's available (meaning less honking), a taximeter, GPS (making it easier to locate lost
  property), and a credit/debit card reader. The credit/debit card reader must be made available
  for use on all trips. In addition, 20% of all Boro Taxi permits sold are restricted for wheelchairaccessible vehicles.
- <u>Safety and Security:</u> Every Boro Taxi is inspected by the TLC twice per year. Also, each Boro
  Taxi has a unique license number (like a yellow cab), and you can use it to file a
  complaint/commendation or retrieve lost property. See the diagram below:

## Did you know???

All Cell Phone Providers Must Recycle Your Cell Phone

The New York State Wireless Recycling Act (Chapter 730 of the laws of 2006) requires **all** wireless telephone service providers that sell cell phones in the State of New York to accept cell phones for reuse or recycling. These businesses must accept up to 10 cell phones from any person or provide a method for shipping the phones for recycling at no cost. Violations may be reported to NYS Department of Environmental Conservation Regional Office.

In Certain Cases You Are Entitled To A Receipt From A Vendor

In NYC if a customer requests a receipt for a purchase between \$5 and \$20, vendors must provide it, and if the purchase is \$20 or more, vendors are required by law to provide a receipt.

By law, receipts must show:

- The business name and address and, if licensed by DCA, it must have "Department of Consumer Affairs" followed by the DCA license number
- The amount of money paid for each item
- The total amount the customer paid, including a separate line for tax
- The date of the purchase
- The make and the model of any electronic purchase more than \$100

Receipts *cannot* show a credit card's expiration date or more than its last five digits.

Residential Cooking Grease Must Be Disposed Of In the Trash Cooking grease poured into a kitchen drain clogs pipes in your home and city sewers. Clogged sewer lines cause sewage back-ups into your home and neighborhood. Clogged sewer lines can also cause sewage to be released into city waterways, harming water quality and the environment.

How Can You Help?

**DON'T** pour oil or grease down the drain.

**DON'T** wash cooking oil or grease from dishes, pots and pans down the drain. **DON'T** wash food scraps down the drain.

**DO** place cooled cooking oil, grease and fat in sealed containers and discard with your regular garbage.

**DO** dry wipe oil and grease off dishes, pots and pans with a paper towel before washing; then discard paper towels in trash.

**DO** scrape food scraps from dishes into trash and dispose of properly.
