I am certain that you have heard about all the candidates for Mayor, Comptroller, Public Advocate and the City Council. These usually receive plenty of media coverage. For the other, less publicized races, you can do your own research to determine who to vote for. Visit NYcourts.gov/vote to learn more about the judicial candidates in your district.

- Judges make decisions that affect our everyday lives, to uphold the constitution and protect our rights.
- Your vote will help determine who should serve as trial court judge in New York State.
- ◆ Your vote will help ensure that the justice system functions properly It's your civic responsibility.

For the ballot propositions, you can also research them before casting your vote:

- Proposal 1: Authorizing Casino Gaming
- Proposal 2: Additional Civic Service Credit for Veterans with Disabilities.
- Proposal 3: Exclusion of Indebtedness Contracted for Sewage facilities.
- Proposal 4: Setting Disputed Title in the Forest Preserve
- Proposal 5: In relation to a Land Exchange in the State Forest Preserve with NYCO Mineral, Inc.
- Proposal 6: Increasing the age until which certain State Judges can serve.

Did you know???

Posting on Trees

It is illegal for any person to affix any handbill, poster, notice, sign, advertisement, sticker or other printed material upon any tree by any means. In addition, affixing any handbill, poster, notice, sign, advertisement, sticker or other printed material upon a tree by means of nailing or piercing the tree by any method shall have an additional penalty imposed equal to the amount of the original penalty. There is a rebuttable presumption that the person whose name, telephone number, or other identifying information appears on any handbill, poster, notice, sign, advertisement, sticker, or other printed material on any item or structure is in violation. Every handbill, poster, notice, sign, advertisement, sticker or other printed material shall be deemed a separate violation. Anyone found to have violated this provision, in addition to any penalty imposed, shall also be responsible for the cost of the removal of the unauthorized postings.

\$10-119, \$10-121(a-e, g) FINE: \$150-\$200 - 1st Offense \$300-\$550 - 2nd & Subsequent Offenses

What is Daylighting?

The process of "Daylighting" an intersection has both safety and operational benefits.

"Daylighting" refers to the process of installing restrictive parking regulations at intersections to improve visibility and safety for motorists. These parking restrictions are designed to help motorists gain an unobstructed view of traffic approaching the intersection, as well as additional travel lanes or turning pockets at intersections. The cost of implementing these treatments is minimal compared to the safety benefits. Daylighting requires only the posting of parking regulations to restrict parking outright along the approaching curb.

If you think an intersection in your community could benefit from daylighting, please contact us and it will be reviewed at our next Transportation Committee meeting.

NEWS from Assemblyman Simanowitz

A bill introduced by Assemblyman Michael Simanowitz which protects owners from being assessed sales tax on water and sewer line protection programs has been signed into law by Governor Cuomo (Chapter 400 of 2013).

"A water line break in New York City can cost a property owner anywhere between \$3,000 to \$5,000." said Assemblyman Simanowitz. "A sewer line break costs between \$10,000 and \$15,000... My legislation has corrected this oversight and property owners who are enrolled will no longer incur this added fee on their bills. I want to thank Governor Cuomo for signing this important piece of legislation and protecting property owners from this needless expense."

DEP has partnered with American Water Resources (AWR) to offer the Water & Sewer Line Protection Plan. Please note that participation is voluntary. If you are interested in enrolling, please contact AWR at 1-888-300-3570.

OUTSMARTING TELEPHONE THIEVES

The Crime Prevention Section would like to give you detailed steps you can take to outsmart a Smartphone thief:

- ◆ Stay in a constant state of readiness; stay alert to lurking predators and unexpected dangers.
- ◆ Avoid leaving your phone on the table at restaurants, bars, and coffee shops.
- ◆ Avoid leaving your telephone in an open handbag and never hang the bag over the back of a chair when out at a store or café.
- ◆ Do not call attention to yourself by walking with your Smartphone in hand when not in use.
- ♦ When traveling by bus or train remain alert and remember that most thefts on public transit occur near bus and train doors.
- ◆ Register your Smartphone with tracking apps. (*Example:* "Find My iPhone" & "Where's My Droid")
- ♦ Register your Smartphone with the NYPD Operation ID program at your local Police Precinct. Ask for the Precinct, Crime Prevention Officer.
- ◆ Password protect your Smartphone.
- ◆ Know your numbers: Smartphone model number, serial number and International Mobile Equipment Identifier (IMEI) number.
