November's Community Board 8 Public Hearing/Meeting (recap) 183-02 Union Turnpike Fresh Meadows

The minutes of Wednesday, October 11, 2023, were unanimously approved by 38 members.

Chairperson's Report:

Second Vice Chair Seymour Schwartz informed the community that Community Board 8 Queens beautification project was not chosen by the Neighborhood Support Team from the Mayor's office. This project was for Hillside Avenue in partnership with Community Board 12.

On Monday, November 13, 2023, Chairperson Martha Taylor kicked off our own beautification project by sprucing up the Midland Mall along with the Department of Parks and Recreation, CB8 staff, Jamaica Estates Association's members, and volunteers. They planted daffodil bulbs, trimmed hedges, turned over the grass and added mulch. They also arranged to have Kingsford Triangle's shrubs pruned, bulbs planted and are waiting for mulch to be laid.

We are also looking to partner with Community Board 12 to spruce up Major Marks Park that is located only across from our district.

NYC Department for the Aging



The Foster Grandparent Program (FGP) is a program for older adults (55+) who wish to work with children in their community. FGP provides an opportunity to serve as mentors, tutors, and caregivers for children and youth with special needs. Foster Grandparents provide anywhere from 15 to 40 hours of weekly service to community organizations such as Head Start, hospitals, public schools, daycare centers, and juvenile detention centers where they provide support to children with special needs children from birth to 21 years of age. Volunteer are given up to \$1,000 monthly stipend and reimbursement for travel and meals. Paid annual and sick leave. They also receive accident and liability insurance while volunteering.

Shubhra Datta - representing Borough President Donovan Richards

Queens Borough President Donovan Richards hosted a Transgender Day of Remembrance Ceremony on Thursday, November 21st at Queens Borough Hall. The Community Board Membership Applications will be available on their website at the beginning of next year.

Deputy Inspector Kevin Chan, 107th Precinct

The community is up thirty percent (30%) in crime. The factor driving up crime is Domestic Violence and Social Media Robberies. Whenever you are selling an item to someone you met online, meet them at the precinct. People with high end watches have gotten robbed.

<u>Paul Graziano</u>, <u>Urban Planner</u> – Report on the City of Yes

Provided the five main components to the housing section and focused on three of the eighteen economic components of the City of Yes.

There are five main components to the housing section:

- The authorization of **accessory dwelling units**. Accessory Dwelling Units would be allowed on all one- or two-family properties in the city. This would allow a basement, cellar, rooms, attic, garage conversion, or a new two-story house behind a house.
- Imposed **transit-oriented development**. This would allow apartment buildings on every single property that has wide streets. On narrow streets, apartment building could be built on every corner.
- Establish **town center zoning**. This would cover every commercial overlay in R1 through R5 zones to allow up to four stories of residential on top of ground floor retail/commercial.
- **Dismantle the zoning resolution** by changing the basic size of your lot. The massive changes would encourage bigger, denser development on smaller lots in all R1-R5 zones.
- Eliminate parking requirements for all new residential development. Any development that takes place, will not have a parking lot.

The following three components of the economic opportunity were mentioned:

- Corner stores This creates a process to allow for small new bodegas and other locally-serving storefronts in residential areas. This would allow commercial retail store fronts or office within one hundred feet of every corner/residential block to go up to twenty-five hundred square feet.
- Home occupations Allow New Yorkers more flexibility to have businesses in their homes. Home offices currently take up a maximum of twenty-five percent of a primary residence and up to five hundred square feet. The proposal would make it forty-nine percent of the residence, no maximum floor area and up to three employees working in your home.
- Adapting spaces for industries like film Give businesses, like film studios, a rational process to allow them to adapt and expand. This would allow the BSA to give a regular permit to anyone that would like to grow their business. If the property has ten thousand square feet, the BSA would give them a permit for twenty thousand square feet.

Health Minutes with Dr. Stern

Dr. Penny Stern gave a moment to recognize Veterans Day and acknowledged Second Vice Chair Seymour Schwartz for being a World War II veteran [this was met by overwhelming applause].

Dr. Stern spoke about World Diabetes Day as being the world's largest diabetes awareness campaign. The campaign was created in 1991 by the International Diabetes Federation and the World Health Organization due to the growing concerns about the escalating health threat posed by diabetes.

World Diabetes Day became an official United Nations Day in 2006 in which we recognize the day on November 14th. You should pay attention to your diet, eat fiber-rich grain products and vegetables. Omit saturated fats from your diet and choose vegetable fats.

ATM Skimming.

The Scam.

ATM "Skimming" occurs when a criminal attaches a phony card reading device over the real card reader located either at the lobby entrance door or on the ATM machine, the phony device looks identical to the real device and is equipped with electronic recorders that will capture the financial information from your card. This data is later used to create "cloned" cards which will later be used to withdraw money.


What Can I Do?






Be careful of ATMs in tourist areas - they are a popular target of skimmers





These devices are usually attached with two sided tape and can be discovered by simply tugging on areas where the card must be swiped.



Skimming device can also be affixed to the card reader at the entrance door to the ATM.



Money Trap

Be aware of "Money Trapping", where the criminal attaches a device to the cash dispenser "trapping" the customer's money and retrieves it after the customer leaves the



Before Using

Give the card reader a tug. See if it feels loose or out of place. Inspect the ATM, gas pump, or credit card reader before using it. Be suspicious if you see anything loose crooked or damaged, or if you notice scratches or adhesive tape/residue.



When entering your PIN, cover the keypad

with your other hand to prevent possible hidden cameras from recording your number.



Immediately report any skimming devices to your financial institution and the NYPD

by calling 911. Safeguard Your Apartment.

TIPS FOR YOUR PERSONAL SAFETY

What Can I Do?



Always use a licensed locksmith. Use a deadbolt lock with a one-inch bolt throw or a heavy duty drop-bolt lock. Install a pick-resistant cylinder. Additional locks should be installed 12 to 18 inches above or below the doorknob. Consider children, the elderly, and/or the disabled before installing a lock too high. Do not use a double-cylinder lock; that is, a lock that has a key on both sides. It can be deadly if a fire breaks out.



Do not enter or remain with a stranger in an elevator if you feel unsafe.



If you live on the top floor of an apartment building, make certain that the roof door is closed, but unlocked. Under NYC Building Code regulations, a roof door may not be locked - temporarily or permanently. It must always allow for an emergency exit.



Use the intercom. Buzz people into your building ONLY when you are absolutely sure of the visitor's identity.



Check your apartment door and door frame. Should they be repaired or replaced? All exterior doors should be either metal or solid core wood (1-3/4" thick).

Window safety tips:

- Any window within 18 feet of ground level, a building projection, or a fire escape is considered to be an accessible opening that should be
- If you live or work in a basement apartment, the windows may be secured with safety gates (or grilles) that contain a safety latch to allow for emergency exits.
- Do not assume that the basement windows are too small for entry. They are, in fact, one of the most popular points of entry for a burglar.
- The best and safest way to secure your fire escape or any first floor window is with a New York Fire Department-approved gate. This gate is commonly known as the "ferry" or "safety gate" and is operated by a latch (not a padlock or combination lock). DO NOT ACCEPT SUBSTITUTES.
