- E-Star: seniors age 65 and over with annual incomes of \$86,300 or less.
- SCHE/DHE: seniors age 65 and over, disabled homeowners with annual incomes of \$58,399 or less.
- Veterans: who served in the U.S. military during designated periods of conflict, their unmarried surviving spouse and Gold Star parents.
- Clergy: for active and retired members of the clergy and their unmarried surviving spouse. Must be NYS resident.

DSNY Night Plow

This is a reminder that the department of Sanitation started its winter schedule known as "Night Plow" on November 13, 2018. This is to ensure that enough staff is available to address snow and ice conditions for the winter. For efficiency, Sanitation Workers are assigned to garbage and recycling removal when there is no snow event. During that time, you may notice a change in the schedule for the removal of your trash and recycling.

Some residents often place their garbage and recycling on their way to work early in the morning and there is usually no issue during spring, summer and fall seasons. Doing so during the Night Plow Season may cause missed collections. To ensure the timely collection of your garbage and recycling, please do place them out the night before. Night Plow ends in mid-April.

Did you know???

NYC Foam Ban

Starting January 1, 2019, New York City stores and food-service businesses can no longer offer, sell or possess single-use foam food containers such as foam takeout clamshells, cups, plates, bowls and trays. Additionally, manufacturers and stores may no longer sell or offer for sale loose fill packaging ("packing peanuts") in the city.

This law was enacted because single-use foam items were found to be not recyclable. These items are collected as trash in the city. There are many recyclable alternative packaging options including paper, plastic, aluminum and compostable products.

The ban begins January 1, 2019 and there will be a six-month grace period before fines will be imposed.

Small businesses with less than \$500,000 in gross income for the most recent tax year and non-profits may apply for hardship exemptions from the Department of Small Business Services (SBS) if they can prove that the purchase of alternative products not composed of EPS would create financial hardship. Who is Covered:

- For-profit or not-for-profit: food service establishments, mobile food commissaries, and stores that sell or use foam items
- Manufacturers and distributors of polystyrene foam packaging that are located or operate within any of the five boroughs of New York City.

What is Covered:

- Single-service foam items including cups, bowls, plates, takeout containers and trays
- Foam loose fill packaging, commonly known as "packing peanuts"

What is Not Covered:

- Foam containers used for prepackaged food that have been filled and sealed prior to receipt by the food service establishment, mobile food commissary, or store
- Foam containers used to store raw meat, pork, fish, seafood or poultry sold from a butcher case or similar appliance
- Foam blocks used as protective packaging in shipping

Notice of Public Comment Period Draft 2019-2020 Unified Planning Work Program

Public Comment Period ends Tuesday, January 22, 2019

The New York Metropolitan Transportation Council (NYMTC) announced a public comment period for the draft Unified Planning Work Program (UPWP) proposed for the State Fiscal Year beginning April 1, 2019.

The UPWP is a federally-mandated product of NYMTC's planning process. It defines planning activities in NYMTC's planning area and identifies federal planning funds to conduct these activities. NYMTC's members will adopt the draft UPWP at their Annual Meeting in March 2019.

Department of Parks and Recreation's Tree Risk Management

As of July 1, 2017, NYC Parks launched a pilot program to better evaluate our trees based on the latest industry standards which are set by the International Society of Arboriculture (ISA). Through applying their professional expertise in risk management, they address the conditions that present the highest risk to public safety and property before other work.

There are three steps taken to assess tree risk:

- 1) Likelihood of tree failure
- 2) Likelihood of impacting target
- 3) Consequences of impacting target.

You can expect the Forestry Unit to address the high-priority work before low-priority conditions (i.e. a hanging limb that can fall and hurt someone would be addressed before a condition that poses less of a threat like a small dead tree). You may notice that certain requests which have low risks take longer to address than in the past.

NEW YORK WEEKEND WALKS

Weekend Walks are multi-block, multi-day events on commercial corridors that promote the use of streets as public space. NYCDOT provides limited funding to community based organizations to close commercial streets and program them to highlight NYC's unique neighborhoods and local businesses.

Business improvement districts, cultural organizations, local merchants associations and community groups can apply to host Weekend Walks. They create wonderful opportunities for New Yorkers to gather and see their neighborhoods in a new way.

In 2019, NYCDOT is embarking on the thirteenth season of Weekend Walks! If you are interested in hosting a Weekend Walks event, go to: myc.gov/weekendwalks

What are the program requirements?

- Events must be on a recurring and predictable schedule
- Consecutive event dates are not permitted (e.g. Saturday 8/16 and Sunday 8/17)
- Must attend mandatory partner meeting in the spring or summer
- All events and programming should be open to the public
- Events must occur along primarily commercial corridors within the 5 boroughs
- Minimum length: 2 blocks, maximum length: 10 blocks
- Minimum number of days: 2, maximum number of days: 10
- Organized by community based organizations with strong ties to the neighborhood they are planning the event in
