Dear Resident,

Last month, we announced our **DOB** in your Community District event! This event is scheduled for Friday, March 15, 2024 from 10 a.m. to 4 p.m. This is to assist our residents with the Certificate of Correction process.

Please remember to contact us to register as soon as possible, as space is limited. There are over 800 Class 1 or hazardous unresolved violations currently.

We recently learned that the Department of Buildings decided to dedicate the month of March to address these issues in the borough of Queens. Their Administrative Enforcement Unit (AEU), that is housed <u>only in Manhattan</u>, is planning to partner with other Queens Community Boards for similar events as ours if they are willing to participate.

The AEU will also be present at the two **Buildings After-Hours Events** at the Queens Department of Buildings [120-55 Queens Boulevard in Kew Gardens] on Tuesday, March 5th and Tuesday March 19th from 4 p.m. to 7 p.m. I encourage you to take advantage of any or both services.

On a different note, the Department of Buildings announced that it has reinstatement fees for expired permit applications. This notice can be found on pages 3 and 4 of this CB8 Newsletter.

# SERVICE NOTICE

# Reinstatement Fees: Abandoned Applications, Expired Permits and Applications, Amended Plans

Abandoned applications, expired permits and applications are not valid after their expiration date. You may be required to re-file or pay a reinstatement fee to complete after expiration. Amended plans that changes the scope of the application may require a new application and new fees.

#### Abandoned Applications

Where no permit has been issued, an application for approval of construction documents or for a permit is deemed to have been abandoned 12 months after the date of submission, unless such application has been diligently prosecuted, which means that some action\* has been taken by the applicant after rejection in whole or in part. (AC §§28-104.2.3, 28-105.7)

The Department may also deem an application for approval of construction documents incomplete 90 days after the Department has notified the applicant that the application is incomplete. (AC §§28-104.2.3)

#### **Expired Permits**

A permit will expire where work has not commenced for within 12 months from date of permit issuance or for a period of 12 months after issuance of the initial permit. (AC §28-105.9)

#### Commissioner Discretion for Extension

The Commissioner may grant an extension of time for additional 12-month periods for both applications for construction document approval and for permits. (AC §§28-104.2.3, 28-105.7)

#### Reinstatement of Abandoned Applications and Expired Permits

Abandoned applications and expired permits may be reinstated or required to be refiled with the associated fee as outlined below pursuant to AC § 28-112.2.

#### Applications Prior to Permit

Abandoned applications in disapproved or approved status with no Code or zoning changes since application was filed.	Full filing fee at the rate in effect on the date of reinstatement	
Abandoned applications in disapproved or approved status with Code or zoning changes since application was filed.	Refile job application and pay full filing fee

#### After Permit Issued

Work has not commenced within 1 year of permit issuance (Permit Expires)	Full filing fee at the rate in effect on the date of reinstatement.		
Work suspended or abandoned for 1 year (Permit Expires), but work is partially complete.	Based on the full filing fee in effect on the date of reinstatement, the percentage of the fee equal to the percentage of work remaining as determined by the DOB inspector, plus the renewal fee.		
Permit expired more than 2 years ago; work complete but without signoffs	\$130 Reinstatement Fee		
Permit expired more than 2 years ago; Code or Zoning change after permit issuance.	Re-File job application and pay full filing fee.		

<sup>\*</sup>Actions include inspection action; PAA filing(s); active temporary Certificates of Occupancy (TCO); and active hearings at the Board of Standards and Appeals (BSA) or City Planning Commission (CPC).

#### Amended Plans

Where there is a change in the scope of work of an application that substantially changes the scope of the application, a new application may be required, and the requisite associated filing fees paid. The Department may allow the applicant to continue the original application for administrative purposes, provided that all associated fees for the proposed scope of work are paid as if a new application was filed for such work.

# ABC's of HOUSING GUIDE (HPD)

Did you know that the NYC Department of Housing Preservation & Development had an **ABCs of Housing Guide** to housing rules and regulations for owners and tenants available online?

This booklet is designed to help New Yorkers gain an understanding of the rules and regulations affecting housing, and to provide information about how to receive assistance.

Inside the guide you will find information about owners' and tenants' rights and responsibilities, staying in your apartment safely, resources for new affordable housing or rental assistance and useful contact information for other housing related issues. Starting March 1, 2024, all businesses in NYC must use bins with secure lids when setting out trash for collection. This new rule is an important step in keeping our streets clean!

This rule applies to any business in New York City, regardless of what is sold. **Any perishable material (trash or organic material) must be in a bin with a secure lid** when set out on the curb for collection. This requirement does not apply to businesses that have waste collected from a loading dock.

#### Store bins inside or outside

Bins should be stored inside or in a rear yard if possible. If space is not available, bins can be stored within three (3) feet of the building line when not set out for collection. Bins must be maintained in a neat and orderly manner and always allow for a clear path of pedestrian travel on the sidewalk.
