October Community Board Public Hearing/Meeting (recap) 183-02 Union Turnpike Fresh Meadows

- The Minutes of the September 14, 2022, Board Meeting were unanimously approved by 33 members.
- Martha Taylor, Chairperson's Report Announced the resignation of Community Associate, Jatnna Reyes, who has accepted a position as a State Trooper. The Board wished her the best of luck in her new endeavor with resounding applause.

On a sad note, Chairperson Taylor announced the passing of former CB8 Member Sylvia Weprin and offered condolences to her family and the Board.

Chairperson Taylor briefly discussed the Mayor's "City of Yes" Proposal. This proposal includes three citywide zoning text amendments to be reviewed next year. She denounced the one size-fits-all approach to the zoning changes. Copies of the PowerPoint presentation was included in the CB8 Member packets and she encouraged them to review it. She announced the formation of an Ad Hoc Committee to be chaired by Deepti Sharma, Chair of the Buildings & Housing Committee.

2022 Ballot Proposals:

- Clean Water, Clean Air, and Green Jobs Environmental Bond Act of 2022 — The proposal would allow for state bonds to be sold to fund environmental projects.
- Add a Statement of Values to Guide **Government** — This proposal would amend the New York City Charter by adding an introductory text, known as a preamble, to the New York City Charter. This preamble would serve as a guiding principle for city government to promote justice and equity for all New Yorkers.
- Establish a Racial Equity Office, Plan and **Commission** — This proposal would create an Office of Equity, require a citywide Racial Equity Plan every two years, and create a Commission on Racial Equity.
- Measure the True Cost of Living This proposal would require the city to measure the actual cost of living for City residents to meet essential needs.

#FDNYSmart Safety Tips for Devices with Lithium-Ion Batteries

Lithium-Ion batteries are used in various devices. These batteries are commonly used in cell phones, laptops, tablets, electric cars, and scooters. Lithium-ion batteries store a large amount of energy and can pose a threat if not treated properly. Like any product, a small number of these batteries are defective. They can overheat, catch fire, or explode.

Be #FDNYSmart if using any devices powered by lithium-ion batteries:

- When purchasing devices, be sure that the equipment has the Underwriters Laboratories Mark. The UL mark shows that the product has been safety tested.
- Follow the manufacturer's instructions for charging and storage.
- Do not charge a device under your pillow, on your bed, or a couch.
- Always use the manufacturer's cord and power adapter made specifically for the device.
- Keep batteries/devices at room temperature. Do not place in direct sunlight.
- Store batteries away from anything flammable.
- If a battery overheats or you notice an odor, change in shape/color, leaking, or odd noises from a device discontinue use immediately. If safe to do so, move the device away from anything that can catch fire and call 9-1-1.

Battery Disposal:

- Putting lithium-ion batteries in the trash or recycling at home is illegal.
- Recycle batteries by taking them to a battery recycling location or visiting nyc.gov/batteries for disposal instructions is always the best option.
- Individually bag batteries or tape ends before disposing.

Littering/Sweeping-Out/Throwing Out

Littering, sweeping, throwing, or casting any material such as ashes, garbage, paper, dust, or other garbage or rubbish into or upon any street or public place, vacant lot, air shaft, areaway, backyard, court, or alley is illegal. Throwing garbage out of windows (for example, from buildings or vehicles) is also a violation. In addition, no person may allow anyone under his/her control (agent or employee) to commit a littering, sweepout, or throw-out violation. Merchants must put all sweepings into suitable garbage receptacles for pickup by a private carter. Residential units must put sweepings into suitable garbage receptacles for pick up by DSNY. Sanitation litter baskets may not be used for this purpose. NOTE: When using a "blower," grass, leaves, litter, etc., must be blown into a pile and properly disposed of with other sweepings.


